

A SOUTH SIDE VIEW OF SLAVERY AND OF NORTHERN INTERFER. ENCE THEREWITH.

An extract from a Discourse delivered at the Methodist Church in Natchez, Mississippi, on the 4th of February, 1861, by Rev. W-

H. Watkins, D. D. The position of the North, in their antag-

The position of the North, in their antagonism to slavery, is not without a pretext, nor is it destitute of plausibility.

They contend that bondage is unnatural, unjust and oppressive. That any system which deprives man of the reward of his toil, or subjects him to the control of another, is tyrannical. That the slave has a right to freedom, and that humanity prompts them to assist him in obtaining it. Some of these positions are mere sophisms. And yet we will not charge them with blind, hypecritical malignity. Their party leaders may be so, but they operate upon a prejudice, and through tempers as inflammable and lawless as decimated France in her riotous revolution. Human passions are alike in all ages, and if the revolutionary spirit of the country be not checked, the waves of anarchy may only begin to war when the Constitution and the Union are crushed into atoms.

If there is wrong in the slavery of the Africans, neither they nor ourselves are responsible for it, nor is it obligatory upon us to repair that wrong, if to do so is to perpetrate a greater wrong. It might not be easy for the people of these United States to produce a title, in equity, to the vast territory of which they boast as "the land of the free and the home of the brave," and yet duty to the savage tribes who once roamed our forests and now perish from our presence. does not require us to surrender our fields

and our cities to their dominion. Natural characteristics form insurmounts ble barriers to equality between races, and social inferiority and political inferiority, must necessarily result. Their state is fixed. modified, ameliorated; it will be as it has been; but the law of Nature, which is the law of God, is immutable. As an inferior race, constituting a part of society, and yet with inevitable distinctions, the superior race must legislate for them without their necessary concurrence. Not by abolishing their natural rights, but for their preservation. We do not deny that instances of injustice and inhumanity occur in the relation of mas-ter and slave; but we deny their more frequent recurrence in this relation than in any other where social inequality is the result of

other where social inequality is the result of the necessity of labor.

Some of the grave questions involved in this controversy, we think, are already settled. The recognition of slavery in these States, and this recognition for the formation of the Union never would have been entertained; the right of the States to control and regulate the institution; the common interest of all the States to any territory then belonging to or to be acquired by the States, and the right of any State thereafter applying, according to the forms prescribed by the Constitution, for admission into the Union, to determine by her own election whether or not slavery should be allowed under her own Constitution.

Constitution.

The question then which disturbs our fraternal relation is not a new one, and yet our concern with it places us in a new re it. It is not how these States are to form a government recognizing this condition of a foreign population domicilated among us, or to prescribe rules and ordinances for its regulation or perpetuity. It is rather, shall par-ties to a contract be allowed, by unfriendly legislation or otherwise, to make void the principles of that contract without the consent of the contracting powers? Ought one party to a government among equals, to submit to such legislation as destroys that equality by forcing upon them legislative acts, which renders their property insecure, and by the will of a dominant party deprive them of the power of redress? Is not the purpose of our Union defeated by this legislation? Can any remedy be proposed by which this party tyranny can be avoided, and this equality be restored, without, in fact and in form, a disruption of this Union?

This alarming state of things has been forced upon us. In part, by the aversion of the old thirteen to the institution per se, and because they saw in it social evil-mainly, however, by the growth of a jealousy to our rapid prosperity and influence in our own and over foreign governments, and a talse philan-thropy which is nourished by ignorance and guided by intolerance.

Books and pictures and ballads have poisoned the minds of the youth of the Northern States for thirty years, while demagogues of all political complexions have influenced the all political complexions have influenced the public mind by misrepresentations, until the deep, broad basis of popular sentiment has inaugurated the irrepressible conflict. For many years our national legislation has been the arena of fiercest conflict. The North and the South, as hostile sections, have contended against each other, each goading the other on to deeds which both saw must ultimate in a dissolution of the Union. I am not here to criminate eithe

the expense of the other. I solemnly avow

my conviction that mutual wrongs have been

done—and by extremists, to produce the threatened disruption. This, however, I charge not upon the great body of the people. They have loved the Union, and desired its I candidly confess that these wrongs, thus embodied, although not sanctioned by the Northern States, as States, and yet aided by the people of the Northern States ought to meet resentments, summary and extreme. For them there is no palliation, and these States are recreant to the trusts which God and society imposes, if they remain inactive

amid a state of things so persions to them-selves and to their country. Interest, honor, duty, demand resistance. It has been my opinion for years, that the South has done herself an injustice upon this question of slavery.

Investigation has corrected the error that condemned it as a moral evil, and yet in the main we seemed to waive discussion. The press has seldom advanced a moral argument in its favor. As a general proposition, leaving the largest liberty in fixing the meaning of servant, as it is used in the Bible, no one will deny that the existence of servitude to a master is recognized in the Bible. man Empire. It is equally a notorious fact, that as an institution, an existing fact, it is not once condemned in all the sayings and doings of Jesus and his Apostles, but that the existing relation was recognized, and the respective duties enforced by the higher mo-tives of a more perfect christianity.

Here we might rest the argument, but we take a position in advance of this, a position no advocate has yet assumed, and yet one as clearly and as fully sustained as is the existence of the relation, to wit: That not only is the institution as an existing fact recognized and legislated for, but that special legislation provides for its creation where it did not exist—thus giving the Divine sanction to the institution per se, and regulating the modes of its creation and perpetuity.-Deut. 15, 12, Lev. 25, 44, 46.

African slavery, the only species of labor suited to this climate, and the growth of cotton has done more for civilization, commerce, wealth, and the uplifting of human society, than any other political institution known to man. I start back with astonisment; I bow down and am thankful when I contemplate this great truth. I ask not who brought them here, or for what; I see them here; mind to requ. special legislation—fixing evated themselves, and fed, and clothed, and the duties and attention the master and his advanced society directly and indirectly had yond every agency known to philosophers and statesmen. Imported Africa has made the wilderness a garden, and the product of the toil of her children clothes and feeds and all questions involving the integrity and enriches the civilized world while a higher civilization and a pure Christianity has been poured into their own souls. A thousand years without it would not have placed mankind where they stand to-day. The hand of God, in our independence, is not more manifest, than has been his interposition to make

African slavery a blessing to mankind.

Nor do our laws abrogate the rights of the slave. They have rights-natural and acquired. They have right to life-God has conferred this. They have right to protection from bodily harm, unless for crime.-They have acquired, by the concession of civilized, enlightened, and Christian masters, right to protection, to trial by jury, and to such social and moral training as elevates them intellectually, and acquaints them with God. Politically, they have no rights. They were brought here to do menial service—they were held to labor by purchase, and God and In all questions American I am an American. nature, and the laws of civilized man, preclude the possibility that they should ever acquire a political right of equality upon this

continent. We deny that they have been deprived of any natural right by being held to slavery, or that they are legally or morally entitled to acquire any political right not already granted to them under our government. They brought none with them and the mere transfer

of ownership created none. I care not how highly they may be educated, how large the political rights legislation may confer upon them, the decree of the Almighty has fixed their status, and a willing-service to a human Christian master is and shall be their largest inheritance.

The existence of the institution cannot be destroyed; its progress cannot be checked. Where climate and production require it, it will certainly go as that the problem of human development is to be worked out.
