BOMBARDMENT CONTINUED.

ANDERSON APPARENTLY DIS-
ABLED.

SIGNALS OF DISTRESS.

THE BREACH IN SUMTER.

THREE VESSELS AND ONE LARGE
STEAMER PREPARING

TO ENGAGE.

EXPLOSION IN SUMTER.

GREAT EXCITEMENT IN CHARLES-
TON.

THE HARRIET LANE REPORTED
SUNK.

CHARLESTON, April 13, 10.30 A. M.—At
intervals of twenty minutes the firing has
been kept up on Fort Sumter all night. An-
derson ceased firing at six in the evening.
He was engaged all night in repairing dam-
ages and in protecting his batteries guns.

He commenced to return the fire at seven
this morning. He seems greatly disabled.—
The battery at Cummings Point does Fort
Sumter great damage.

At nine a dense smoke poured from Sum-
ter. The federal flag was displayed at half
mast, signalling distress.

The shells from Fort Moultrie and Morris
Island fell into Anderson's stronghold thick
and fast. They can be seen in their course
from the Charleston armory.

The breach made in Sumter is on the side
facing Cummings Point. Its port holes are
knocked into one, and the walls from the top
are crumbling.

Three vessels and one large steamer are
over the bar and seem to be preparing to par-
ticipate in the conflict. The ships have not
yet opened fire.

LATER.

An explosion has occurred at Sumter. A
dense smoke was suddenly seen to rise. An-
derson ceased firing for about an hour—his
flag still up.

It is thought the officers' quarters at Sum-
ter are on fire.

ANOTHER ACCOUNT.

CHARLESTON, April 13.—Morning.—An-
other account says the batteries at Sullivan's
Island, Cummings Point, and Stevens' bat-
tery are pouring shot and shells into Fort
Sumter. Anderson does not return the fire.

Sumter is still on fire.

There has just been an explosion at
Sumter.

SECOND DISPATCH.

CHARLESTON, 2 o'clock.—Anderson's mag-
azines have exploded. Only occasional shells
are fired at him from Fort Moultrie. The
Morris Island battery is doing heavy work.

It is thought that only the smaller mag-
azines exploded.

The greatest excitement is caused. The
steeples and every available place is packed
with people.

The ships in the offing have not aided An-
derson. It is now too late to come over the
bar, as the tide is now ebbing.

THIRD DISPATCH.

CHARLESTON, April 13.—Twelve ships are
in the offing, and appear to lie quietly at an-
chor. They have not fired a gun.

The entire roofs of Anderson's barracks
are a sheet of flames.

Shells from Cummings Point and Fort
Moultrie are bursting in and over Sumter in
quick succession.

The federal flag is still waving.

Anderson is occupied only in extinguishing
the flames. Every shot seems to tell. The
people are anxiously looking for Anderson to
strike his flag.

FOURTH DISPATCH.

CHARLESTON, April 13.—The fleet outside
has been signalled by Anderson.

The Harriet Lane is reported to have been
sunk by the harbor batteries.

FROM MONTGOMERY.

MONTGOMERY, April 13.—The President
and the Secretary of War were surrounded last
night. The latter said the Confederated flag
would soon be waving over Sumter and from
the Federal Capital at Washington, if their
independence was not acknowledged and if
hostilities continue.

Only one despatch was received from
Beauregard last night. Matters were be-
lieved to be favorable.

The President has appointed T. Warren
Morse Judge of the District of Louisiana.

Beauregard telegraphed the Secretary of
War late last night that there was heavy
firing all Friday; four guns in sumpter dis-
mounted; confederate batteries safe; nobody
hurt; four steamers off the bar; sea rough.
The War Department has received nothing
from Charleston to-day.

FROM WASHINGTON.
THE VIRGINIA COMMISSIONERS' IN-
TERVIEW WITH THE PRESIDENT.
WASHINGTON, April 13.—The Virginia
Commissioners held a pleasant interview with
the President to-day. The result was simply
the statement that he will act according to
the Inaugural programme, hold the public
property and defend it—waging no war
against seceding States and maintaining the
defensive.

The President's reply is given in writing.

OFFER OF TROOPS FROM RHODE
ISLAND.

PROVIDENCE, April 13.—Gov. Sprague has
offered to Government the Marine Artillery
and 1,000 infantry, and offers to accompany
them himself.

FROM BALTIMORE.

BALTIMORE, April 13.—Men wearing the
Secession cookade were pursued by a crowd
to-day. They were obliged to be protected
by the police.

SAILED.

NEW YORK, April 13.—The New York
took 177 passengers. The Kangaroo left her
dock with 150 passengers. She may not go
to sea till morning.

FROM SAVANNAH.

SAVANNAH April 13.—The lights in the
Tybee and in the harbor are discontinued for
the present.
