

CAMP BENTON, Dec. 20, 1861. A few days before our regiment received or-ders to join General Lyon, on his march to any controversy with regard to the case of Milson's Creek, the drummer of our regimen was taken sick and conveyed to the hospital and on the evening preceding the day that we were to march, a negro was arrested within the lines of the camp and brought before our captain who asked him, "what business he had within the lines?" He replied, "I know a drumme that you would like to enlist in your company and I have come to tell you of it." He was immediately requested to inform the drumme that if he would enlist for our short term of se vice, he would be allowed extra pay, and to d this he must be on the ground early in the morning. of the reveille, a good looking, middle-age woman, dressed in deep mourning, leading b the hand a sharp, sprightly-looking boy, apparently about twelve or thirteen years of age Her story was soon told. She was from East Cennessee, where her husband had been killed by the rebels, and all her property destroyed. She had come to St. Louis in search of her si ter, but, not finding her, and being destitute of money, she thought if she could procure a situation for her boy as a drummer for the short time we had to remain in the service, she could find employment for herself, and perhaps find her sister by the time we were discharged. During the rehearsal of her story the little fellow kept his eyes intently fixed upon the countenance of the Captain, who was about to xpress a determination not to take so small ooy, when he spoke out, "Don't be afraid Captain, I can drum." That night I was detailed for guard duty, my turn of guard closing with the morning call. When I went out with the officer as a relief, I found that my post ras upon a high eminence that overlooked the eep ravine-in which our men had engaged the nemy until Totten's Battery came to their asistance. It was a dreary, lonesome beat. The moon had gone down in the early part of the night, while the stars twinkled dimly through a hazy atmosphere, lighting up imperfectly the surrounding objects. 
