



The Recent Victory.

The joyful news of the recent success of the the telegraphic wires yesterday, was an earnest of the expected power of the great expedition which has been so long fitting out at Cairo and

Fort Henry is situated fifty-five miles up the Tennessee river, on the east bank, near the boundary line between the States of Kentucky and Tennessee. It stands in the river bottom just below a bend of the stream, and at the head of a straight stretch of two miles. Its armament was 17 guns, mostly 32-pounders, with one 10-inch columbiad, and was commanded by Gen. Tilghman. A battery was placed on the opposite bank. The possession of this Lecture Room, at the usual hour of service. Ad fortification gives the National forces free passage on the Tennessee river to the center of Smith, Rufus S. Pickett, George W. Jones and Tennessee, and this, together with free passage upon the Cumberland, will enable the Government to forward supplies, while our troops shall press on to Memphis. Should the latter be taken, Columbus must fall without any great struggle, being cut off from supplies.

Commodore Foote, who commanded the expedition, is a son of Ex-Gov. Foote, of this To his Honor the Mayor and the Common Council of the State, who resided in Cheshire, in this county. The Commodore is a resident of this city, and distinguished himself a few years since in the reduction of the Chinese forts. The New York Times says of him:

Commodore Andrew H. Foote, who so gallantly led the gunboats in the action at Fort Henry, is a native of Connecticut, and entered the service from that State in 1822. Since that time he has been continually in service, making the whole time of his naval career extend over forty years. He is still, however, full of the fire and vim of youth, and is one of the best specimens of the old sea dogs in America. Over twenty years of his time he has been on ocean clearly. twenty years of his time he has been on ocean service, cruising in almost every sea; ten years ployed. He received his commission as commander in 1852, and was last at sea in 1858. Brooklyn Navy-yard : but about eight months ago was assigned to the duty of superintending the putting up of the great Mississippi flotilla.

Senator Johnson Exposing the Traitors Senator Johnson of Tennessee, made a scorching speech on the resolution for the expulsion of Senator Bright from his seat in the U.S. Senate. In the course of his remarks he alluded to the defeat of the Crittenden compromise, about which so much has been said by the "peace party." At that time Senator Benjamin refused to vote Mr. Johnson said to him, "Mr. Benjamin why don't you vote? Why not save this proposition, and see if we cannot bring the country to it? Benjamin answered that he would control his own action without consulting any body. Yet, as soon as the vote was taken, he and other traitors telegraphed through the South, "We cannot get any compromise," "Here," says Senator Johnson, "were six Southern men refusing to vote." He adds, "they accomplished their object by witholding their votes; and hence the country has been involved in the present difficulty."

Mr. Johnson next alluded to the two-thirds vote of the two houses for an amendment of the constitution, so as to prohibit Congress from ever after interfering with the institution of slavery in the States, making that restriction a part of the organic law of the land; yet not one of the rebel States have taken up that amendment and said they would ratify it!

He next alluded to the passage of the bills for the organization of three new territories, Dacotah, Nevada, and Colorado, which bills provided that the Legislature should have no power to legislate so as to impair the right of private property-leaving all these questions, not to the territorial Legislature, but to the people when they should come to form a State Constitation. Mr. Johnson in commenting upon these



European Interference.

The latest intelligence from Europe in regard to American affairs, is encouraging to the friends of the Union. A Washington correspondent of the New York Times states positively that private letters from members of the British Cabinet affirm that no intervention in American affairs is intended, but on the contrary, that their purpose and wish is to remain entirely neutral.
