



WASHINGTON, May 27, 1862. By dispatches received at the War Department we learn that affairs are quiet in the vi-

cinity of Harper's Ferry.

A message from Gen. Banks, dated 1 o'clock this morning, says that Capt. Collis of the Zouaves de Afrique brought his command into Hancock, having had two killed. A later dispatch from Banks, says all is quiet at Williams-

Washington News.

WASHINGTON, May 27, 1862. Advices from the City of Mexico, to the 5th inst., state that in the latter part of last month the British minister had concluded a treaty at Peubla, with Doblado, by which all difficulties with the English were amicably settled.

Had it not been for the sudden action of the French, a treaty with Spain would have been concluded between Doblado and Gen. Prim.

The latter, however, left the shores of Mexico on good terms with the Juarez Government, and a Minister will be sent to Madrid to arrange satisfactorily all matters in dispute.

The President of the United States has de clined to impart to Congress the correspondence relative to affairs in Mexico since his last message. He regards it as inexpedient to do so at

[GENERAL ORDERS, No. 23:] 1. The President of the United States having made requisition for another Regiment of Infantry from this

State, the Commander-in-Chief directs that Volunteers be enrolled sufficient to organize one Regiment, to be designated the 14th Regiment of Infantry, to serve for three years or during the War, unless somer discharged. 


