In case of failure on the part of the contracts to deliver the several articles which may be ordered from them, in proper time and of proper quality, the chief of the Bureau of Provisions and Clothing shall be authorized to purchase or direct purchases to be made of what may be required to supply the deficiency, under the penalty to be expressed in the contract; the record of a requisition, or a duplicate copy thereof, at the Bureau of Provisions and Clothing, or at either of the navy-yards aforesaid, shall be evidence that such requisition has been made and received

Two or more approved sureties in a sum equ 1 to the estimated amount of the respective contracts will be required, and twenty per centum will be withheld from the amount of all payments on account thereof as collateral security, and not in any event to be paid untill its in all respects complied with; and eighty per centum of the amount of all deliveries made will be paid by the navy-agent in certificates of indebtedness or in Treasury notes at the option of the Government.

Dr. Gregory was shot at the same point last Friday week, while wa tering his horse in the St. Francis just at sundown. Dr. G. was in company with Chaplain Dunmore and many others, but he rendered himself conspicuous by wearing full uniform Suddenly they were fired upon by the enemy concealed behind the bluff on the opposite sid of the river. Eight shots were fired, and one ball passed through his arm, crushing the humerous close to the shoulder, through the axilla and coming out a half inch from the spine, and there entered his horse, inflicting a mortal wound on the animal also. Dr. Gregory lived until Monday last. He was attended by Lieut Johnson, M. D., of my squadron, who, in company with the Chaplain watched by the dying in hand watched by the Doctor's couch until morning, when he died. Lieut. Johnson hav ing embalmed the body accompanied it to this point. With this exception our officers have worn a private's uniform. A rebel force is said to be marching agains

The Gunboats up the Appomattex-Their Interview with the Rebels---Shot and Shell Salutation

UNITED STATES STEAMER PORT ROYAL, APPOMATTOX RIVER, June 27, 1862. MESSRS. EDITORS: Ran down to Jamestown day before yesterday evening, and returned to City Point at 4 p. m. yesterday. Commander Rodgers, commanding the squadron of James River, came on board this vessel with his boat's crew and some marines-Very soon ran up signal for the squadron to "weigh anchor"-all soon under way, stood by City Point leaving the "Galena" to warm them there if necessary, her draft of water not admitting of her going with us. We entered the Appomattox River, the "Stepping Stones" going ahead and buoying out a channel over the bar. This done we took the lead followed by the other boats, viz: Monitor, Mahaskas, Maratanza, Delaware, Southfield, Stepping Stones, Jacob Bell, and Island Belle. After steaming some six miles we came the Shore Line Railroad on Sunday night, was to a narrow pass in the river, (this was at 8 p. Lawrence Moore, who resided at Millstone Point, m.), and suddenly like a clap of thunder volley followed volley and rifle shot came against our sides and over us. It reminded me of being in a barn in a hail storm. We were not long in letting "sliver" our pivots and howitzers, the squadron soon following in the chorus. The Monitor, Maratanzas, and this vessel singing bass, the Stepping Stones and Island Belle giving tenor, while the others put in the teniable. Under this enchanting music the enemy "skedaddled" at about 9 o'clock p. m. This was a free concert and brought the house down. We had the misfortune to get aground, made signal to our consorts, who, in company with us, kept up a steady fire until midnight, clearing the woods effectually. Having got afloat again we dropped down about a mile and came to anchor. The Maratanzas also got ashore and we had to wait the rise of tide for her. Our men lay down after midnight all "harnessed" and ready for a call, and I assure you I was not long in getting into the arms of the sleepy "Morpheus." I snoozed like a woodchuck for I felt rather tired. This morning early a contraband came on board and said that we last night had killed a number of gentlemen and some horses, also a negro child. He hoped that we would not fire on them any more (the negro fraternity he meant), as the negroes were quite thick about Capt. Rodgers gave him to understand that he did not come here to kill negroes or negro children, but that if the enemy fired on the squadron, they would be paid in their own coin. I am pretty certain many bit the dust. Our man at the mast head heard such expressions as 'Oh my God!" and says he saw one man laid out at our first discharge. The riflemen were as near us as the fence about the Green is to the Park House, -and they were in strong force.-Talk about a watchman's rattle making a cracking. You might as well compare the song of the canary to the death yell of an Indian .-Such a cracking as we kept up for four hours, a person seldom hears. This "night work," al though very nice in some points, is also very dangerous—especially when the "blue pills" come by the pickage—and the channel of the river is crooked as a Secesh rail fence. By this expedition, which was a sort of "feeler" out how things stood up this branch of the lames River, we, by optical observation, in formed ourselves that the enemy had resorted to his old game, viz: had the channel barrica-ded with vessels loaded with boxes of tobacco and barrels of stone, about seven miles from the river's mouth. Four Men Hung at New Orleans. The Deputy Provost Marshal, Stafford,

He was uneducated, but rather intelligent and capable He was quite tall and robust, and not ill-look ing, though his countenance was, in a marked degree, lacking in frankness and honesty. He was an only child, and his parents have been spared by death from the disgrace which his felon's death wou'd have brought upon them. Stanislaus Roy, alias Pat Murphy, was born in Lower Canada, at a little place thirty miles north of Montreal. He was twenty-six year of age, and had resided in New Orleans for the last nine years, working part of the time at his trade as saddler and sometimes as bar tender His reputation in this city was that of a thief. He was unmarried, and leaves his parents and

rith a furtive, repulsive expression of co

New York, where his parents and two brother evidently led an exemplary life: but getting into evil company he became wild and addicted to unlawful practices. He was married with about twenty years of age, but did not live with his wife long. Early last winter, or in the fall, he went to New Haven, where, under the asumed name of Newton (he declined giving his rue name), he married again, and in February nlisted in the Connecticut Thirteenth regiment. In person he was nearly six feet tall and very stalwart, with a shallow face, large peculiar blue eyes, and short, bristling black hair. He was a weaver by trade, and though illiterate, could converse and write in English that was al-

lishman by birth, and had been in this coun only a year. He was thirty-three years old, and a mariner by profession. He leaves a wife and three children in Brooklyn, New York. He was apparently of a surly disposition, and not inclined to be communicative. He drank incessantly of whiskey the morning before his execution, but owing probably to the excitement under which he was laboring, he did not appear to become intoxicated. CHAPTER I.

A By Law relative to sching Squibs, Torpedoes, and Fire Crackers.

Be it ordained by the Court of Common Council of the City of New Haven, That no person shall sell or expose for save in the City of New Haven, any fireworks commonly called squibs or crackers, torpedoes, serpents, or other fireworks of what nature or description roover, except in packages containing each at least one thousand, under a penalty not exceeding twenty-five dollars for any such offense, and whenever the offense stall be committed by a minor, the parent or guard: an shall be liable for the penalty.



Additional Troops to be Sent Into the The Governors of the several loyal States have put their shoulders to the wheel and of-

fered the services of more men for the purpose of putting down this rebellion. The President concurs in their views as expressed and decides to call 300,000 more men into active service to close the war in as short a time as practicable. To day the quota for each State is to be announced and the number will be speedily enrolled with the great Union army now battling for the rights of their country.

From the river the first rise is about fifty feet "toping lift," (a rope leading from the mast-head for most of the way quite steep. The second rise, which at the landing begins about too steep for a horse to climb. In some localities for many acres hardly a tree can be found that is not scarred and bored through by shot. Hundreds were cut clean off by the larger balls. Some lofty oaks, two fee through in the trunk, were splintered and split and finally laid low by a succession of hard hits In the bole of one, yet standing, I counted four 6-pound shot lodged, and one had pierced quite through ten feet above the ground. Others are left bare masts, completely shorn of their limbs. In places the ground is strewn with branches so cut off.

Emerging into an open space further on, and the source of this bavor appears in a battery on the further side. The story is that this battery was captured by the rebels and retaken six times during the fight. Some of the guns and carriages were sprinked with the blood and prains of men who perished at their post. In other places the trees were thickly peppered with rifled shots. Many had from ten to forty bullet holes, and in one over sixty were counted

One spot which I cane upon, had plainly been the scene of a desperae, protracted and deadly conflict with rifles. The trees were large with dense underbrush and young growth. Here every trunk was literally covered with scars or side toward the river, and the shots were seldom over six feet high. For acres the small growth was all cut off at a height of from three to four feet. Hundreds of the young oaks were completely girdled by cars, and dead, with the first spring growth withered, as the leaves were out half folded. But sadder marks than these attested the fierceness of the fight and the sure aim of the combatants. The ground was blackened by the putrifying gore from which yet arose a sickening sterch; scores of fresh earth mounds were to be seen on every side, some in he usual shape of grave, but more marking its, into which several bodies had been hidder from sight. But, alas, all were not thus hidden, the work of decent barial for so large a host as the dead of that battle on both sides had been too much, and so many were but slightly coverd as they fell, crouched down in hollows, or uddled up by the side of old logs.

A letter from Fortress Monroe on Sunday states that four forage trains sent from White House to Dispatch Station on Saturday, met rebel pickets and backed down to White House. where the cars were burned, the engines blown up, and the ambulance and baggage wagons were rolled into the river, there being no time to destroy them. The rebels were not in sight of White House Point Sunday morning when a steamer left. The buildings at White House burned all night and were completely destroyed.
