# Our Army on the James Biver.

BALTIMORE, July 6, 1862. > THE REBEL ARMY AND REBEL TACTICS. I have conversed with a number of men who were in the several battles, and they concur in their statements of the magnitude of the rebe army. What the Rebels at Richmond Say. The Richmond papers are studying the real results of the late contest with McClellans forces. They comment upon the new position assumed by him, enumerating the numerous advantages pertaining to it, among which are the superior facilities of transporttaion, while their ammuni tion and stores must be wagoned a distance of nearly thirty miles.

The Examiner speaking of Berkely says: "The western landing is perhaps the very best on James river, and the stream for miles up and down being broad and deep, affords ooth excellent sea room and anchorage for his gunboats and transports; but this is by no means the only advantage of the position. the west of Berkely are innumerable impassible ravines, running from near the Charles city road on the north, to James river, making uccessful attack from that quarter next to impossible. Within a quarter of a mile from where these ravines begin, Herring Run creek crosses the Charles city road, and running in a southeasterly direction skirts on the north and east the plantations of Berkely and Westover, and empties into James river at the extreme eastern boundary of the latter. The whole course of this creek is one impassible morass, while along its northern and eastern banks extend the heights of Evelinton, a long range of hills that overlook the Westover and Berkely estates and which offer an eligible position for

heavy guns.

It will be seen that, protected on the south by the river and his gunboats, on the west by impassible ravines, and on the north and eas by Herring creek and the heights at Eveling ton, the enemy's position presents but one preg nable point, the piece of level country north west of Westover, from a quarter to half a mile in width, lying between the head of the ravines and the part where Herring creek crosses th Charles city road. But it is certain that the enemy, with his immense resources of men and nachinery, will, in a very brief period, obstruct by art this only natural entrance to his strong old. Already it is within range of his gun boats, and of his siege guns, planted on the Evelington hills. Another day may see it strewn with felled timber, and bristling with field batteries.

It adds: "Ten days ago, when McClellan beleaguered Richmond, with the exception of about five miles of the Chickahominy low grounds, he occupied the most barren and at the same time the worst watered and most unhealthy region of Eastern Virginia. Agues, hop poles and whortle berries, have been always the only sure crops of the country. 

### Finding Fault with the Government.

Nothing is easier than to detect errors other people's conduct, unless it be to commit them ourselves. Unfortunately, perfection is not a human attribute. In private life, in order to render existence in any measure endurable, we are continually forced to overlook the faults of our associates, and to throw ourselves upon their kindness and forbearance for the pardon of our own. If the little duties of private life cannot be discharged without mistakes, it is not to be presumed that in public life men will be any more successful, especially when they assume the grave responsibility of guiding the nation through times of difficulty and peril. It was a mistake of the Emperor Napoleon, that caused him with all his great military the ocean, instead of the ruler of an empire

To this general rule of imperfection, how ever, there appears to be some notable exceptions. Our reader will at once discover that we refer to the conductors of a portion of the beginning. Success is always the result of their counsel, adopted by their favorite Secretary or executed by their favorite General. No two of these-papers exactly agree in their wisdom. One insists that a new Secretary has infused new life into an army that under the mismanagement of a general has remained dormant and inactive. Another is equally certain that the general has gained a victory despite while a third is positive that the President taking his rightful authority into his own hands, has overruled secretary and general, and become the sole author of victory. But whoever may be the mere agent of success, they all insist that the primary cause of it was the adhering to plans which they themselves had devised .-And inasmuch as some of these papers devise every imaginable plan, and support no single one two days in succession, it is quite possible that they may sometimes be right. Such fertility of invention, and facility in changing front as some of these papers exhibit, should certainly be rewarded by an occasional correct guess

But if, while affairs are progressing favorably, and the government seems to enjoy the unqualified confidence and approbation of these unappreciated statesmen in private life, who are boldly proclaiming that our army will be in Richmond in a few days, a reverse takes place and our army is obliged to retreat, the telegraph can hardly bear the news with lightning speed to New York, before you will discover to your unutterable chagrin that these Editors, in stead of having confidence in the government, have long been perfectly aware that there was " something rotten in Denmark," and that an imperative necessity existed for a radical change both in the Cabinet and in the field. And now, if we may be pardoned a somewhat familiar simile, as hounds in full pursuit of a flying fox, when once the scent is gained, join in deep loud-mouthed baying at their frightened foe, so these papers send forth to the country one general howl of rage, the most malignant that pen can record or human spleen can in vent. No one is safe from their invectives. Cabinet officers are cursed for what they have done or failed to do; experienced generals are denounced for not knowing what no one could know, and the President is given to understand that he must not presume too much upon the forbearance of the public, and that his tenure in office is quite uncertain unless he shall comply with the "demands of the people," as expressed in these volcanic ebullitions of frightened and years of age. irascible editors. It was only a little more than a week ago that one would have inferred from an article in the New York World, that a revolution was about to break out in that establish ment, and editors, compositors, pressmen, devil and news-boys were about to proceed to Washingtor to make President Lincoln give an account of himself and to inform him what Statesmen he must place in his Cabinet, and what Generals in the field. Such wholesale denun ciation undoubtedly makes a very spirited article, and gives character to a paper, but whether it is a desirable character, or conducive to the public good, we leave it to the editors to deter-Were the councils of such advisers to be followed no general would fight two successive battles, and the Cabinet would be changed once

We are not by any means an advocate of a blind unreasoning faith either in men or in principles. Judicious criticism is always proper, and the acts of a General are as legitimate a necessary that subject of criticism as those of a Statesman, population.

But confidence in those who are conducting the war is essential to success, and should not be rashly weakened. The people have faith in President Lincoln and will sustain him. When he needs men and money he has but to ask for them. To this work of maintaining him in his arduous task the Press of the Country should neartily contribute. We certainly do not pro pose to clamor for the removal of a General whenever his pickets are driven in, nor to make every reverse the signal for a breaking up of the Cabinet. On the contrary we shall do what we can to sustain the Government and welcome every man who is willing to contribute in putting down the rebellion.

#### General Pope's Address to Soldiers.

Washington, July 14, 1862. The followings speaks for itself

To the Officers and Soldiers of the army Virginia:

By special assignment of the President I have ssumed command of this army. I have spent two weeks in learning your whereabouts, you condition and your wants, in preparing you for active operations, and in placing you in positions from which you can act promptly and to the purpose. In but one instance has the enemy been able to place our Western armies in a defensive attitude. I presume I have been called here to e the same system, and to lead you agains the enemy. That opportunity I shall endeavor to give you; in the the meantime I desire you to disreminiscence of the past? Four years ago I miss certain phrases, which I am sorry to find stood in my place in this Hall, and participated much in vogue amongst you. I hear constantly of taking strong positions and holding them, of lines of retreat and of bases of supplies tion a soldier should desire to occupy, is one from which he can most easily advance against the enemy. Let us study the probable lines of retreat of our opponents, and leave our own to take care of themselves.

Let us look before us and not behind. Suc cess and glory are in the advance, disaster and shame lurk in the rear. Let us act on this understandingly, and it is safe to predict that your banners shall be inscribed with many a glorious deed, and that your names will be dear to your countrymen forever.
