T the Annual Meeting of the Board

AT the Annual Meeting of the Board of Health of the Town of New Haven, held on the 31st day of May, A. D. 1863, the following Orders were passed: Ordered. That the Northern Quarantine Limit for the Harbor of New Haven, and contiguous waters, be a lime drawn from the North-East corner of Hotchkiss' R pe Wark, in the Oyster Point Quarter, in New Haven, to Fort Wooster, on Beacon Hill, in East Haven; and that the Southern Limit be a line drawn one West from Fort Hale, in East Haven, to the Beach, in New Haven; and the portion of the Harbor and contiguous waters, between said lines, shall be the place where vessels arriving, if need be, shall perform Quarant ne.

Ordered, That the fees of the Health Officers, for visiting and giving bills of Health to vesse's subject to Quarantine Regulations, for the year ensuing, shal be three dollars, and no more; excepting vessels laden with the produce of, and coming from the Bithish North Amrican Provinces, and vessels coming out of Chesapeake Bay, or from any portor place upon said Bay, for which no fees shall be paid.



AVigorous Prosecution of the War.

If there is any one thing upon which the loyal people of this land are agreed, it is in desiring a vigorous prosecution of this war. The sentiment of the graduates of Yale College, yesterday, at the Alumni meeting, was clear and outspoken. That meeting was composed of men from all parts of the North, of all professions, and holding diverse political views. But there was only one feeling upon this question. The nation must be saved. Whatever assails the national life must die-whatever can help to preserve the nation must be employed. "A free State." said Dr. Bacon vesterday,

"is a great University. The State of Connec ticut is a University." The men who have been educated in this university of a free State have learned to think for themselves. And the voice of a free people to-day is ready to go up with a shout which shall be heard in Washington, assuring the President that he need not wait for the advance of public sentiment. The people are already ahead of their rulers. They ask now, that every thing consistent with civilized warfare, and not subversive of the Constitution, shall be done to suppress this rebellion When an assassin is seeking your life, the quicker you let blood out of his heart the better. And if there is any method by which this rebellion can be reached more effectually and economically than by encamping our Northern soldiers in Southern swamps, let that method be tried. If there is any way by which the sympathy of the four millions of blacks can be secured, and their services diverted from the rebels to us, let that way be discovered at once. We urge this, not for the sake of abolition or emancipation. We urge it for the salvation of our distracted and suffering country.

There is no propriety in assuming that the slaves are loyal or disloyal. But there is an evident propriety in our finding out whether of James L. Cowles of the first class, and William they are the one or the other: that, if they ar disloyal, we may fight them as we would every other enemy of our country; but if they are loyal, that we may welcome them to the national cause and hopelessly weaken the indus- H. Died at Harrison's Landing, Va., July 16th, 1862, of ty-hoid fever, Lieut. John D. Jsbell, of Springfield, Mass., ormerly of Union City, (Naugatuck.) Conn., aged 22 years, MESSRS. EDITORS: The memory of this young man deserves something more than the nere announcement of his death. Mr. Isbell was a native of Union City, Conn., where his parent, John L. Isbell, Esq., at present resides, out for the last two years previous to the breakng out of this war, had been a resident of Springfield, Mass. About 11 months ago he resigned a lucrative position to enter the service of his country in the capacity of Assistant Quartermaster of the 18th Mass. Vols. His habit of close attention to business, which had ecured for him the respect and confidence of his employers in mercantile life, gained for him promotion as Lieutenant, which position he held at the time of his death. He was a young man of promising abilities, of upright character, universally esteemed, and his loss is an irreparable one, not only to his relatives and friends, but to the community, and his fellow soldiers and his country. About four months since Lieut. Isbell was bereaved of his mother, and although during her sickness he made every effort to secure leave of absence that he might visit her, Commencement of the 162d Anniversary of Yale the exigencies of the service were then such that he could not be spared from his post. A few days before the news of his death reached his friends, his father received intelligence that he was sick and would come home on a fur lough. Accordingly, his father, sister, and friends repaired to the depot at the appointed time to welcome him home, but he came not, he was even then dead. The next news they re ceived were the tidings that he was no more His death, following so recently that of a wife and mother, seems to his parent and sister al most unendurable; but in their sad affliction they have this to comfort them-he died a pa triot, soldier, and a Christian. Yes, they may now take consolation from the words dying mother: "John is a good boy-if he is killed in battle he will meet me in heaven.' By the kindness of the Colonel of his regiment his body was embalmed and sent home to Union City. His funeral took place from his father' residence last Friday, and was attended by large concourse of people. Proceedings in Case of Alarm.

Sec. 73. The commander-in-chief or, in his absence, the major-general may, on an alarm, invasion or notice of the appearance of an enemy, e there by sea or land, order the whole, or any part of the milita, to assemble, and may lead, order, employ them for the assistance or relief of any of the inhabitants of the state attacked by an enemy, or in any danger of being attacked, and may issue and publish such orders as he shall judge expedient to carry into execution the intents of this act; and all subordinate officers commanding brigades, regiments and companies, shall have the same suthority within their respective commands; but when either of them shall find it necessary to order out the force under his command, he shall forthwith dispatch intelligence of such order, and the occasion thereof, together with an account of his movements and operat oas, to the commander-in-chief, or to any of his superior officers, as re may deem most conducive to the public safety; and the officer receiving such intelligence shall observe the same line of conduct, in order that the information may, in the most expeditious way, come to the commander-in-chief; and when any company, regiment, brigade or division of the milita of this state shall be ordered into service by the proper officer, on any alarm, each non-commissioned officer, musician and private, who neglec's to appear at the place of rendezvous, in person or by substitute, and j.in the company to which he belongs, shall be dealt with accordingly; and each non-commissioned (fficer, musician and private, shall have the same notice, when ordered into service by company, regiment, brigade or division, as is provided in this crapter for taoze who are called out by detachments.

TEN REBEL IRON-CLAD GUNBOATS Arrived at Mobile from England. Снісадо, July 30, 1862.

The Times' special, dated Memphis, July 28th, says that late advices from the South, from rebel sources, are very important. Ten iron-clad gunboats, built in England, have arrived off Mobile harbor, and three more are on

These gunboats constitute the fleet ordered by the Southern confederacy in Europe. They mount from ten to thirty guns each, and are said to be mailed with 6-inch iron. The blockade was run, openly, by dint of superior strength and weight of metal. Mobile is now considered open to the world with the support of her newly acquired naval power.

Indiana Democratic Convention. Indianapolis, July 31, 1862.

The Indiana Democratic State Convention assembled in Capitol Square at 10 o'clock this morning. The attendance was very large, there being from three to five thousand present. Thomas A. Hendricks, of Indianapolis, was chosen President, Robert Lucas, Vice President. and J. G. Bingham, editor of the Sentinel, Secretary. A committee of one from each Congressional district was appointed to prepare

The President on taking the Chair, after thanking the Convention for the honor conferred upon him, remarked that no Democrat would disturb the peace, but probably some of the outsiders would.

He recommended the members of the con

vention to pass such persons by, as unworthy of notice. No attempt had been made at disturbance and probably none was thought of. Gov. Wickliffe then addressed the convention He was for the Union, provided the rights of the South and slavery were not interfered with. Before doing any thing more he would pause to see what we are fighting for. If it is to free the negroes let not another drop of blood be shed-he would hang the leading rebels and balance the rope with the abolitionists. The abolitionists control every department of the Government, and were worse than the rebels Representative Richardson of Illinois, Senato Carlisle of Va., representative Voorhies of Ind. and other distinguished gentlemen were present.

The great rebellion against our government prompt response to the call for three hundred thousand troops. If these troops are raised forthwith no nation of Europe will for a moment entertain the thought of intervention, while the rebels themselves will either be obliged to surrender at Richmond, or to evacuate their capital. There is not an officer in the army, nor a member of the government at Washington who doubts the truth of this proposition; and the President is prepared to use all the men that are furnished, in a manner which every patriot will approve. Is not the prize to be gained worth effort? It is almost in our grasp-think of it-the suppression of this mighty rebellion, the restoration to our homes of the friends who are fighting for their country, the cessation of this war, and the final establishment of peace, not with a country divided and dishonored, but united under one government, with the old flag still "known and honored throughout the world." All this may be achieved, will be achieved, if the patriotism of '61 can again be kindled. And while it is desirable, words cannot tell

how desirable, that the required number of be remembered that patriotism does not cease with volunteering. There are thousands who cannot well volunteer, who would most cheerthemselves were to be drafted. And if the soldiers do not come forward, and offer themdraft. No administration can withstand the rebellion shall be permitted to succeed, without having first exhausted every expedient for suppressing it. And not until every patriot capa-Government appreciates this fact, and prepa tions for a draft are fast being made both at Washington and in a number of Northern States. We can save Connecticut from it if we with increased rapidity. Bounties must be voted freely, and the cities must fill up their quota. The labors of harvest will soon be over and the country towns will then furnish the men required of them. But here, in New Haven, let men be careful how they discourage volunteer ing, and bend all their energies to the work of filling our regiment and sending it forward to the relief of our brave army.

A Major General Appointed. His Excellency, Governor Buckingham, has tendered the appointment of Major General of the State Militia to Hon. William H. Russell, of this city, and Mr. Russell has accepted the appointment.

This announcement will be received with joy by all who feel any interest in a militia organization and who know Mr. Russell. A better selection could not have been made. We are quite certain now that a militia will be organized. The executive ability of Mr. Russell would insure that, aside from his military knowl-

The office of Major General at the presen time is no sinecure. There are duties to be performed, unknown to officers in a perfected organization. The force is not only to be drilled; it must be created. And to a considerable extent the energy and tact of the Major General will be the agency by which this will be done. In appointing Mr. Russell, the Governor has shown great wisdom; in accepting the appointment Mr. Russell has sacrificed his private convenience for the good of the State.

The Way to Make a Draft Necessary

There is a class of people in our community who are very much disturbed by the idea of a draft. They may thank their own blindness if one becomes necessary. For in the first place they have done all they could to prevent volunteers enlisting, both by the general tone of their conversation, and by personal appeals to any one of their number who felt disposed to enlist, generally succeeding in destroying any patriotic impulse with which their friends might have been seized. And in the second place they have always been exceedingly unwilling that any one should fight for us except white men of the purest blood. They have clamored loud and long against employing the slaves of rebels to assist us in fighting. When men are so unwilling to receive help the natu ral inference is, either that they propose to de all the work themselves or that they do not desire to have the work done at all-in othe words, that they design to suppress the rebellion by enthusiastically fighting for the Union, or that they do not wish to have the rebellion suppressed.

The temper of the American people is not such as to bear any very marked demonstrations of the latter spirit; and if these persons do not

propose to do anything themselves to help suppress the rebellion, they would do well to cease their clamors against persons who will do something. At all events, every attempt to discourage enlistments protracts the war and renders a draft more inevitable, beside being an exhibition of base-born treason, disgraceful beyond expression!

An Act relating to the Militia.

Be it enacted by the Senate and House of Repr CHAPTER IX.

General, field, orminissioned and staff officers shall, for disobedience of orders, unofficer-like conduct while on duty, or during any day appropriated for military exercise or p rade, and for the neglect of any duty imposed upon them as officers of the militar, be subject to trial by general court-martial, according to the usage and pract ce of war; which court-martial shall consist of not less than five nor more than seven mambers; and the senior officer, who shall always be of a rule superior to the officer on trial, shall pre-side. A court-martial, for the trial of an officer under the grade of a field officer, shall be appointed by the commanding officer of the brigade to which be belongs; for the trial of an officer of the division; for the trial of a general officer, by the commander-inchief. And in every court-martial there shall be a judge-advocate, who shall discharge the duties of that office according to the usage and practice of courts-martial; and no other parson shall be admitted to prosecute or defend the arrested (filteer. Absent Officers and Soldiers.

ORDER BY SECRETARY STANTON WAR DEPARTMENT, Washington, July 31, 1862.—The absence of officers and privates from their duty under various pretexts while

receiving pay at great expense and burthen to the Government makes it necessary that effi-cient means be taken to enforce their return [GENERAL ORDERS, No. 74.] to duty, or that their places be supplied by those who will not take pay while rendering no service. The evil moreover tends greatly to discourage the patriotic impulse of those who would contribute to support the families of faithful soldiers. It is therefore ordered by the President, first, that on Monday the 11th day of August, all leaves of absence and furloughs by whomsoever given, unless by the War Department, are revoked and absolutely annulled, and all officers capable of service are required forthwith to join their regiments under penalty of dismissal from the service, or such penalty as a court martial may award, unless the absence be occasioned by lawful cause.

11th day of August, are: first, the order or leave of the War Department; second, disabilities from wounds received in service; third, disabilities from disease that renders the party unfitted for military duty, but any officer or private whose health permits him to visit watering places or places of amusement, or to make social isits, or walk about the town, city or neighborhood in which he may be, will be considered fit for military duty, and as evading his duty by absence from his command in the ranks; fourth, on Monday, the 18th day of August, at 10 o'clock, a. m., each regiment and corps shall sition on the be mustered, the deserters marked, 3 lists of the ry blanks. same made out, and within 48 hours of the muster, one copy shall be sent to the Adjutant-General of the army, and one to the commander of the corps, the third to be retained, and all officers and privates fit for duty, absent at that time, will be regarded as absent without a cause. Their pay will be stopped, and they will be dismissed from the service or treated as deserters unless restored; and no officer shall be restored to his rank unless by the judgment of a court of inquiry, to be approved by the President; he shall establish that his absence was without a cause: fifth, commanders of corps, divisions, regiments and detached posts are strongly enjoined to enforce the muster and return aforesaid; any officer failing in his duty herein will be guilty of gross neglect of duty, and will be dismissed from the service; sixth, a commissioner shall be appointed by the Secretary of War to Superintend the execution of this order in the respective states.
