PHILADELPHIA, Aug. 25, 1862. The Bulletin has information from a gentle man who left the Rappahannock yesterday norning, that our troops had frequent skirmish es with the Rebels while falling back from the Rapidan. The losses on either side are not se

Our troops are distributed along the river and have resisted all assaults. They will be able to maintain their positions until a junction with the other army corps enables them to resume the offensive. The rebels are endeavoring to turn our right and get in our rear by the way

How 2,000 Rebels were Entrapped.

New York, Aug. 25, 1862. A Rappahannock correspondent of a Phila delphia paper says: On the morning of the 21st the rebels opened a battery on our center, and continued vigorously to throw shot and shell for several hours.

A little higher up it was discovered that the nemy had, during the night, erected a bridge over the river. At this point the most brilliant and successful affair of the day is reported to have occurred. In the vicinity of this bridge was one of Gen. Sigel's batteries on which the rebels opened a brisk fire, to which, for a time, our batteries replied with spirit. In a little while our fire slackened and then ceased, the battery having been apparently silenced or withdrawn. Three rebel regiments now rushed across the bridge and Sigel offered no opposition. Everything seemed favorable; but alas! the scene soon changes. No sooner have they crossed than Sigel opened his batteries on the

bridge. The fourth shot complely demolished it, and at the same time a deadly fire of musketry assails the rebels in front. Their retreat is cut off. No hope is left. A few shots from our

battery, a charge and they are ours. Not a man escaped-nearly two thousand are said to have been captured and about four hundred killed and wounded.

The enemy having failed in this attempt, ow hurl forward their forces with impetuosity and strive to out-flank Sigel by crossing at French's Ford; but Gen. Pope orders up Banks and Reno to the aid of Sigel and the enemy is again repulsed and moves higher up the river. How the next attempt of the enemy succeeded I have not yet learned.



#### The Campaign.

The forward movement of Stonewall Jackson is the natural result of the events which are transpiring in the North. The vigor with which our Government is acting, the alacrity with which the people are responding to the call for six hundred thousand men, the cheerfulness, with which even a proposition for a draft is received, are all calculated to show the rebels that the North is in earnest. They now see clearly that the real power of the loyal States is to be exerted against them as never before, and that unless some decisive victory can be gained before our new troops shall be placed in the field, the days of the Confederacy are numbered. As if fortune favored their schemes, the position of our armies a few days since was all that they could desire. Our troops, outnumbered largely by theirs, were divided into three armies, sepato each other. When, therefore, McClellan commenced his retreat, a most opportune moment had arrived for striking us a fatal blow Not only were his forces diminished by the reinforcements that had been sent with Burnside, but no army can fight as hopefully on a retreat as in an advance. We waited for the news of a fearful battle, or of McClellan's safe arrival at length the good news came that the army was safe Days pass by, during which every hour is of priceless value to us, as the new regiments of the loval States are being mustered into service, hurried off to Washington, and then pass over into Virginia. Every hour brings strength to our army and hope to our cause. But suddenly the news comes that Pope is retreating. his whole army, seeking to turn the flank of Pope's army, and overwhelm him before Mc Clellan can arrive. Here is real danger. At the very moment when victory, decisive and final, is almost in our grasp, we are again in danger of a terrible defeat. A few hours of anxious suspense glide by and the telegraph brings the welcome news that Pope, McClellan and Burnside have joined their forces. If this proves to be true, it may not, indeed, prevent the enemy from attacking our army. A bloody battle may soon take place, or may already have been fought. But the golden hour for th rebels to strike has passed. Jackson will find it bloody work to hurl his Southern legion upon two hundred thousand Northern veterans commanded by such Generals as Pope, McClellan, and Burnside. And yet such an attack by

## The Postal Currency.

We have been shown specimens of the new postal currency. The stamps represent the value of 5 cents and 25 cents, each printed in deep brown, upon yellow, heavy bank note paper and of 10 cents and 50 cents, printed in green on white paper. The green and yellow tints render them non-photographic, and thus they cannot be counterfeited through that process The "postal currency" will be issued by agent of the treasury department, and not by postmasters as has been erroneously understood. These diminutive bank, notes are executed in the very highest style of the engraver's art, and are really very beautiful. They will be delivered to the public in sheets. A sheet of fivecent notes will be one dollar; a sheet of tencent notes will be two dollars; a sheet of twentyfive cent notes will be four dollars; a sheet of shot. fifty-cent notes will be eight dollars. A very heavy penalty is provided against selling these stamps at a premium

We have also been shown specimens of the new legal tender treasury notes of the denomi nations of \$1 and \$2. They are beautiful specimens of bank note engraving, and will no doubt be speedily in general circulation.

General Buell has issued an order forbidding any officer or soldier in his department, who may be captured, from giving his parole to the enemy not to serve in the army until he shall be exchanged, unless such officer or soldier shall have the written permission of the General Commanding, to do so. The giving of paroles had come to be a serious calamity at the West, where Morgan was roaming through the country taking prisoners and then releasing them on parole. In this way the enemy were not troubled with prisoners, while the Union forces were weakened. The order of Gen. Buell is a timely one.

EXECUTIVE MANSION, WASHINGTON, Aug. 22, 1862. Hon. Horace Greeler: Dear Sir-1 have just read yours of the 19th, addressed to myself, through the New York Tribune. If there be in it any statements or assumptions of facts which I may know to be erroneous, I do not now and here controvert them; if there be in it any inferences which I may believe to be falsely

drawn. I do not now and here argue against them; if there be perceptible in it an impatient and dictatorial tone, I waive it in deference to an old friend whose heart I have always suposed to be right. As to the policy I "seem to be pursuing," as Escaped citizens came into the fort during the ou say, I have not meant to leave any one in

doubt. I would save the Union: I would save it the shortest way, under the Constitution .-The sooner the national authority can be restored, the nearer the Union will be to the Union as it was. If there be those who would not save the Union unless they could at the same time save slavery, I do not agree with them. If there be those who would not save the Union unless they could at the same time

My paramount object in this struggle is to save the Union, and is not either to save or destroy slavery. If I could save the Union without freeing any slave, I would do it, and if I could save it by freeing all slaves, I would do it, and if I could save it by freeing some and leaving others alone, I would also do that. What I do about slavery and the colored race I do because I believe it helps to save this Union, and what I forbear I forbear because I do not believe it would help to save the Union.

I shall do less whenever I shall believe what I am doing hurts the cause, and I shall do more whenever I shall believe doing more will help the cause. I shall try to correct errors when shown to be errors, and I shall adopt new views so fast as they shall appear to be true views. I have here stated my purpose according to my view of official duty, and I intend no modification of my often expressed personal wish, that all men, everywhere, could be free. Yours, A. LINCOLN.



#### The Letter of the President to Horace Greeley.

We recollect no precedent for the course Mr. Lincoln has taken in answering, in a public manner, a letter addressed to him through the columns of a public print. Had any precedent been needed, Mr. Lincoln is not a man who quibbles about forms when they stand in the way of the accomplishment of his objects.

Mr. Lincoln's reply to the letter of Mr Greeley is characteristic of the man. It is straightforward, unequivocal, comprehensive He is determined to save the Union. If to do this he is obliged to lay violent hands on the pillars that support the institution of human slavery, he will not hesitate to do so; but he will do it only as a means by which to attain the great and all important end of preserving intact the integrity of the nation. He clearly indicates that he waits the march of events, and that by the criterion which they shall afford, will be form his judgment of what duty de mands. That he believes events are placing him in such a position that he can rightfully use the power to destroy slavery if the welfare of the nation shall seem to demand it, is clearly shown in his declaration-" If I could save it [the Union] by freeing all the slaves, I would

Abraham Lincoln can be trusted. Every deed that he performs testifies that, in his official capacity as President of the United States, he is acting upon the grand principle he once uttered-" Let us have faith that Right makes Might, and in that faith let us dare to do our duty, as we understand it." Cautious-not cowardly; judicious-not time serving; Abraham Lincoln declares explicitly-"I intend no modification of my oft-expressed personal wish that all men, everywhere, could be free.' He will do his duty; and pushing straight forward to the one point of saving the Union of these States and preserving the supremacy of the Constitution, he will swerve neither to the right nor to the left. And the people will sus

Horace Greeley to Abraham Lincoln. Horace Greeley, Editor of the New York Tr bune, has addressed to the President, through the colums of his paper, a letter two columns in noth-too long for insertion in full in our col ums. We will, however, give the substance

and point of his remarks.

Premising that a great proportion of those who triumphed in the election of Mr. Lincoln and all who desire the unqualified suppression of the rebellion, are sorely disappointed by the policy he seems to be pursuing with regard to the slaves of rebels, Mr. Greeley sets forth wha he thinks the people require and what they com-

First-They require of him " to execute the laws" of the land, and more especially "such laws as have been recently enacted" and "may therefore, fairly be presumed to embody the present will and to be dictated by the present needs of the Republic"-laws that the President has approved after due consideration.

Second-He complains that the Presiden does not enforce the new Confiscation Act.

Third-He complains that the President " unduly influenced by the counsels, the repre sentations, the menaces, of certain fossil politi cians hailing from the Border Slave States.' He appeals to such unconditional lovalists as H Winter Davis, Parson Brownlow, the Union Central Committee of Baltimore and to the Nashville Union newspaper, as evidence "that the heartily, unconditionally loyal portion of the white citizens of those States do not desire that slavery shall be upheld to the prejudice of the Union." He asks Mr. Lincoln "to consid er that slavery is everywhere the inciting caus and sustaining base of treason; the most slave holding sections of Maryland and Delaware be ing this day, though under the Union flag, in full sympathy with the rebellion, while the Free Labor portions of Tennessee and Texas, though writhing under the bloody heel of treason, are unconquerably loyal to the Union." He urges upon Mr. Lincoln that had he "from the first refused to recognize in those States, as here, any other than unconditional loyalty-that which stands for the Union whatever becomes of slavery-those States would have been and would be, far more helpful and less troublesome to the defenders of the Union than they have been or now are."

Fourth-Mr. Greeley thinks "timid counsel in such a crisis calculated to prove perilous. and probably disastrous." He urges that "it is the duty of a Government, so wantonly, wickedly assailed by Rebellion as our has been, to oppose force to force in a defiant, dauntless spirit. It cannot afford to temporize with traitors nor with semi-traitors,"

Fifth-Mr. Greeley complains "that the Union cause has suffered and is now suffering immensely, from mistaken deference to Rebel Slavery." He believes that had Mr. Lincoln in his Inaugural Address, unmistakable given notice that, in case the Rebellion already commenced were persisted in, he "would recognize ne loyal person as rightfully held in slavery by a traitor,"-"the rebellion would therein have received a staggering if not a fatal blow." " As it was, every coward in the South soon

Sixth-Mr. Greeley complains that the

fiscation Act that Mr. Lincoln has approved, and that they go unrebuked therefor; that the officers of our armies "have habitually repelled rather than invited the approach of slaves who would gladly have taken the risks any business matters connected with the Palladium of escaping from their masters to our camps, bringing intelligence of inestimable value to former office. the Union cause." He complains further that slaves who have escaped have sometimes been "brutally and madly repulsed and often of the New Orleans Sunday Delta of Aug. 10th. surrendered to be scourged, maimed, and tortured by the ruffian traitors who pretend to own them." He complains further that "a large proportion of the regular army officers, with many of the volunteers, evince far more the Rebellion." And finally, that Mr. Lincoln, elected as a Republican, knowing well what ar abomination slavery is and how emphatically it is the core and essence of this atrocious rebellion, seems never to interfere with these atro-Seventh-Mr. Greeley calls Mr. Lincoln's at-

tention to the fact that a considerable body of slaves left plantations thirty miles from New Orleans and made their way safely to that city, where they expected to find freedom under the protection of our flag; they were there "met with hostility, captivity and murder"-"they were set upon and maimed, captured and killed because they sought the benefit of" the Confis cation Act,-"they were butchered or re-en slaved for so doing, by the help of Union soldiers enlisted to fight against Slaveholding Treason." And, says Mr. Greelev, "it was omebody's fault that they were so murderedif others shall bereafter suffer in like manner, in default of explicit and public direction to your Generals that they are to recognize and obey the Confiscation Act, the world will lay the blame on you.

Eighth-Mr. Greelev asserts that "there not to be found on the face of this wide earth' a single "disinterested, determined, intelligent champion of the Union cause who does not feel that all attempts to put down the Rebellion and at the same time uphold its inciting cause, are preposterous and futile-that the Rebellion, if crushed out to-morrow, would be renewed within a year if Slavery were left in full vigor." To sustain this point Mr. Greeley appeals to the testimony of our Ambassadors in Europe. He appeals to Mr. Lincoln to "ask them to tell him candidly whether the seeming subserviency of his policy to the slaveholding interest is not the perplexity, the despair of statesmen of all parties [in foreign lands, ] and be admonished by the general answer!"

Ninth-Mr. Greeley closes his letter as he began with the statement "that what an immense majority of the people demand is a frank, declared, unqualified, ungrudging execution of the laws of the land, more especially of the Confiscation Act," which "gives freedom to the slaves of Rebels coming within our lines, or whom those lines may at any time inclose." And concluding, he says: "As one of the milions who would gladly have avoided this struggle at any sacrifice but that of Principle and Honor, but who now feel that the triumph of the Union is indispensable not only to the existence of our country but to the well-being of mankind, I entreat of you to render a hearty and unequivocal obedience to the law of the

An impressment vas made in Fayette and Madison Counties and loval owners were paid laborers' wages for their slaves, while rebel owners were referred to the slaves. It was not found necessary to take the negroes of many loyalists. The rebels are in great distress in consequence of the impressment as many of their negroes were taken while working in the hemp fields. Loyalists commend the measure as just and wise.
