A BY-LAW TO, AND IN ALTERATION OF A BY-LAW EN TITLED "A BY-LAW REGULATING PUBLIC HACKS AN

OTHER CARRIAGES." Be it ordained by the Court of Common Council of the City of New Haven: of New Haven:

Section 1st. That the following places in the City of New Haven be, and the same are hereby assigned and established as the Stands whereat the Public Carriages for the conveyance of passengers may at all times, except on the Sabbath, stand, waiting for employment, viz:

1st.—In College street, on the West side thereof, between Elm st. and Chaple 1st. the horses attached to the same to stand facing the South.

2d.—In Chapel street, on the North side thereof, between Temple st. and College street, the horses to stand facing the West.

3d.—In Church street, on the West side thereof, between Chapel street and Elm street, horses facing the South.

4th.—In Orange street, on the West side thereof, between Court street and Elm street, horses facing the South.

5th.—State street, on the East side thereof, between the

South.

State street, on the East side thereof, between the
Merchant's Hotel and Chapei street, shall be devoted exclusively to Stages and Omnibuses, horses facing the
Month.

6th.—In Crown street, on the South side thereof, be-tween Church st. and Temple street, horses facing the West; but no Carriage will be allowed to stand within twenty-five feet of either side of the cross-walk, which crosses said Crown street, directly opposite Music Hall, twenty-five feet of either side of the cross-walk, which crosses said Crown street, directly opposite Music Hall, except while discharging or receiving passengers.

7th.—In Union street, on the East and West sides thereof, between Chapel street and Cherry istreet, Hacks and Carriages excepting as hereinafter named, may stand, horses facing the crosswalk extending from the main entrance of the Depot to the Union House.

Pravided, That no Public Hack or other Public Carriage shall stand within ten feet of the intersection of any such streets, or of such other places as may be designated by the Mayor. The Mayor is also authorized to give instructions as to what Express Wagons are to have precedence in the delivery of freight at the Railroad Depots or Steambat, and the Hacks and other vehicles are required to make room for such Express Wagons, at such times as the Mayor may prescribe.

The West side of Union street, from south of the south basement entrance into the Depot to the northerly line of Cherry street, shall be exclusively devoted to the accommodation of Express Wagons. And the drivers of said vehicles shall place their wagons in a line, with the hind wheels thereof to the curb-stone, on said West side, commencing at a point two feet Seuth of said South basement entrance, and extending on said line to a point not nearer than six feet to the northerly crosswalk on the line of Cherry street.

SEC. 2d. Such openings shall be left at the Railroad De-

wheels thereof to the curb-stone, on said West side, commencing at a point two feet Seuth of said South basement entrance, and extending on said line to a point not nearer than six feet to the northerly crosswalk on the line of Cherry street.

SRO. 2d. Such openings shall be left at the Railroad Depot in Union street, for the accommodation of the United States Mail Wagon, as may be designated by the Mayor. Openings shall at all times be left at said Depot, not less than twenty-five feet, on each side of the Westerly end of the crosswalk in said Union street, which crosses said street between the said depot and the Union Hous; for the accommodation of carriages, while discharging from said Railroad Depot with passengers; and the driver of each and every Public Carriage, while discharging or receive the same, as the case may be, with as little delay as possible, and then drive immediately away.

SRO 3d. Whenever it shall become necessary, for the reasonable accommodation and convenience of any Carriage or Carriages, or the driver or drivers thereof, for any other Carriage or Carriages to move in any direction, the driver or drivers of such Carriage or Carriages as ought to move, shall, when requested so to do by a Policeman, move such Carriage or Carriages, so as to reasonably accommodate others, and allow the greate thossible number of Carriages to stand in and upon said Hack Stand. And if the driver or drivers of any Public Carriage or Carriage shall refuse or neglect to remove his Carriage as aforesaid, or shall refuse or neglect to remove his Carriage from the place or places designated for the United States Mail wagon, or if any Carriage shall be found without a driver, which shall need moving for any Policeman to move such Carriage or Carriages, and the horses attached to the same.

SEO. 4th. When a train of cars enters the Depot of the New York and New Haven Railroad, except trains of the Carriage or Express Wagons, and shall not obstruct the platform, or mingle with the passengers, until the baggage is re

any section especially applicable to Carriages or Hacks only.

SEO. Sth. Any person thrice convicted of any violation of this By-Law or the By-law to which this is an addition or alteration, shall be deprived of his liscense, and be debarred of having such license renewed for and during the person of one year from the date of said third conviction.

Sec. 9th. If any driver, owner, or person having charge of any public Hack, or other public Carriage for the conveyance of passengers, or any other person, shall refuse or neglect to conform to the foregoing By-Law, or shall in any respect violate any of its provisions, he shall forfeit and pay to the City Treasurer, for any such offense, the sum of not less than five nor more than twelve dollars.

SEO. 10th The Third section of the By-Law to which this is in addition and in alteration, and the By-Law passed becember 16th, 1861, relating to Hackmen, Potters, and Expressmen be, and the same are hereby repealed.

The Future Hopeful.

It is not by any means an occasion for di couragement that the war has been transferred from the vicinity of Richmond to that of Wash ington, or that our army instead of besieging the capital of the enemy is now defending our own. If we can successfully protect Washing ton, and we see not the slightest cause to doubt the ability of our troops 'to do so, it is much better, for many reasons, that the decisive battle should be fought at Bull Run, than on the Peninsula, or even at the gates of Richmond. That such a battle should soon be fought, a battle which will destroy one of the grand armic now facing each other but a few miles from ou Capital, seems at this moment inevitable. And not only do our hopes, but our judgment, lead us to believe that it is the rebel host that will this time be made to bite the dust, and to taste the bitter cup of disaster which a year ago, almost upon the same ground, they administered

We have heretofore said that the rebels we astonished at the uprising of the North-at th readiness with which volunteers have entered the national service, and above all, at the patience with which the order for a draft was received. The spectacle of 600,000 men flocking to the national standard was not a pleasant one for them to contemplate. With their whole force matched by the Union troops already in the field, the rebel leaders saw at once that unless one terrible blow could be struck before these new troops could be brought into action, the hopes of the Confederacy were ended. They would strike a blow that should annihilate the veterans of Pope and McClellan, place Washington at their mercy, throw open the North to their victorious legions, and command the Pope, McClellan, Halleck and Burnside. [Aprecognition and admiration of the world, or they would lose all in the attempt. They have chosen their position, and the result will be one of the alternatives they foresaw. That it cannot be the first is now evident. That it will be the second we earnestly hope, and with a good degree of confidence expect.

We cannot discover, in the accounts which have reached us of the recent battles, anything particularly discouraging. The enemy suffered their position. Our own troops, on the following pears, we have suffered no greater loss than they. But since that last engagement our forces have been strengthened by the arrival of 60,000 veterans, the best soldiers in our army, who have marched forward to the assistance of Pope, and will be ready for the next engagement. And beside this, new troops, not disciplined, indeed, but yet valuable as reserves, have been pressing forward to Washington from the loyal States by thousands. These have been thrown between the disciplined troops and Washington, and still the stream of new levies pouring into the Capital is undiminished. Each day, therefore, adds to the power of our army, while that of the enemy is not increased.

Moreover, the march of the enemy was to sudden and rapid for the transportation at the same time of full supplies. The want of these must necessarily embarrass the rebels somewhat, while our forces, by the change of position, are brought nearer to supplies and reinforcements.

The expedition of the enemy was one of the boldest and at the same time most desperate on record. It bears all the marks of Napoleonic daring; but it is the movement of men fearing that all is lost rather than of those confident of final triumph. They have not succeeded in what they attempted. They have found themselves checked at every point. And could they exchange their present position for the south bank of the Rappahannock, we doubt not they would gladly do so. Instead of transferring the war to Maryland, they find themselve nearly surrounded by our troops, an advance and retreat being alike difficult. Thoroughfare Gap is watched by our forces, and nothing remains for Jackson but to fight one terrible battle, on the result of which the safety of him self and army, and the hopes of the Southern Confederacy will depend. For that conflict our own army is ready, and we shall await with confidence the news of a decisive victory the present week.

THE FIFTEENTH REGIMENT.

FIRST NIGHT IN CAMP—THE BATTLE AT The National Blues and McClellan Guards having BULL RUN-THE FOURTEENTH-"CAMP CHASE," ARLINGTON HEIGHTS, Virginia, Aug. 31, 1862.

Here we are stationed about four miles from Washington, on the direct road to Bull Run Our trip from New Haven was somewhat te-We left New York Thursday evening by boat to Amboy, and from thence by rail to Philadelphia, reaching Philadelphia early Friday morning. Here we were taken in charge by the "Union Volunteer Refreshment Committee," who supplied us with breakfast, and otherwise treated us with much kindness. This Committee are untiring in their exertions to provide for soldiers passing through their city The saloon used for providing refreshments wil accommodate four hundred and fifty soldiers at time at the tables. Outside there are, along the walk, forty basins, with spiggots, where each soldier can wash and fill his canteen with pure water. Up to the present time about two hundred and fifty thousand soldiers have been cared for by the Committee, who have never asked or received any money from the city, State, or United States Government-the institution being mainly kept up by the voluntary contributions of the citizens of Philadelphia and vicinity. From Philadelphia we came through to Baltimore and were detained ther over night till Saturday morning; left Baltimore early and reached Washington at noon After a short detention there we came out here and slept on the ground, the tents not reaching ere till this morning.

During the early part of the evening we could hear distinctly the firing which was going on in the Bull Run battle. This morning we got news that Pope has Jackson cornered, and has won a great victory. But you will get the news quicker than we.

The Fourteenth, C. V., is ahead of us, in

Fort Richardson, and in sight of us. Our men are all in fine spirits, and stood the journey well. I write hastily, as we are all up in heaps just told, you know, that we are here in shape When we get settled I will write you a letter.

N. B.—Only four men deserted us on the rip-few regiments get through without losing ten times that number, each. Friends may di rect thus: A- B-. Co. - 15th Regiment, C. V., Camp Chase, Washington, D. C.

From New Orleans.

A private letter dated Aug. 22d, received from an officer of the 13th C. V., at New Orleans, says that the steamers are now busy bringing our troops from Baton Rouge. "As fighting men in all, will concentrate at Carrolton and meet what forces Breckinridge and Van Dorn can bring against us. Our regiment has orders to march at a moment's notice and take the right wing of the line. Butler likes this regiment and accordingly has given it the post of honor.

Butler's last order in relation to arms ha had a good effect. Many thousand stands of arms have been brought in, and now slaves ar earning their freedom by reporting concealed weapons. The poor fellows rejoice at having a chance given them at last and seizures are constantly being made."

THE LATE BATTLE BEFORE WASHIGTON.

Washington, Sept. 2, 1862. A gentleman who returned from the battle field this morning, reports that in Saturday's fight our left wing was commanded by Gen. McDowell, but owing to the murderous enfilading fire of the rebels he was compelled to fall back. Gen. Sigel commanded the centre and Gen. Kearney the right. It appears that our forces attacked the enemy in the words, from which the latter opened numerous batteries causing great slaughter. The rebels suffered equally as much as our own troops. Our men, fearless and determined, fell back about one mile, leaving our dead and wounded upon the field. Our informant says that our main forces were five miles from Centreville on Sunday, in battle array, and prepared for all emergencies, having been strongly reinforced. All the wounded have been removed from the battlefield of Thursday and Friday, which was, yesterday, still in our possession. The scene of the conflict of Saturday, the enemy still occuwe have not force enough in this division to py. The cars come in this morning from the hold the place it is to be left and destroyed by first named field, bringing many wounded, some the gunboats. Stuart's cavalry was dashing up and accordingly raised an alarm. The panic spread almost with the speed of electricity and doubtless would have been prolific of serious consequences had not the guards on the road rushed forth with pointed guns and threatened to shoot the drivers unless they returned to the field. This conduct on the part of the guards had the desired effect, as after a while the ambulances again returned to the field and performed their appropriate duty in bringing away the wound- this office, after which skelet in companies will be filled by ed. Ambulances are constantly arriving here with the wounded and a small proportion of the sick From all that can be gathered we have suffered severely. A large number of stragglers on their way to Washington and Alexandria were picked up by the rebels during last night. Our city to day is lively in a military view, but sad as to the constant exhibition of returning invalids. There was no fighting of consequence on Sunday, only occasional skirmishing or a few shots poured into the woods from time to time on the who left Centreville on Sunday morning gives enemy as if to try the range of our guns. From the severe conflicts previously it was evident both armies were engaged in repairing damages. 

At Cumberland Gap, Grand Junction, Bolivar and Lexington our troops have met with reverses or have been compelled to retreat. It is even reported that the enemy are marching on Louisville, while the proclamation of martial law in Cincinnati, Newport and Covington, reveals the fact that our commander, General Lewis Wallace, fears for the safety of those places. Thus everywhere at the same moment, the enemy have assume the offensive, and are pressing the war with unwonted vigor. Their Generals have doubtless been impelled to this course both by the conviction that the present is their only hour of hope, and by the clamor of the Southern people, who have long demanded that the North should be made the battle-ground of the war.

Meanwhile, what is General Buell doing We ask the question, not rhetorically, for the purpose of answering it, but earnestly, to secure an answer from some one who can give the information. We should like to hear the answer from booming cannon in East Tennessee That Buell is always slow, painfully slow, every one familiar with this war knows. But he cannot now remain inactive. He must move or the enemy. It is generally supposed that he has at his disposal, though not immediately under his command, an army of one hundred thousand men. That this force should have pressed through Kentucky and Tennessee, and entered Mississippi in triumph, and should then become an absolute cypher in the contest, while the enemy are pressing to the Ohio and threatening the free cities of the Northwest, is painful in the highest degree. But this cannot continue. The army of Buell is composed of the very best fighting men, and unless the inactivity of camp life at Corinth has totally demoralized them, the rebels will soon find a force

It has been our misfortune in this war that energy in one section of the country has been the signal for inaction in the others. The de sire to see something accomplished has caused the Government to send out each expedition as soon as prepared, without waiting for others to co-operate with it. But the scale upon which the preparations for the future are now being made is such as to soon enable every one of our armies to resume the offensive, and drive the enemy back to the cotton fields of the South.

If our Generals in the West display proper energy, the success of the rebels must be of short duration. The new volunteers will soon place the safety of Cincinnati beyond a doubt. It only remains for Buell to once more unfurl the standard of the Union in East Tennessee and while his own ranks are rapidly filled by the loval men of that region, he will be able either to cut off the retreat of the enemy, or to compel them to retreat much more rapidly than they have advanced. Energy on his part will save the West. Delay, at a moment like the present, is criminal. For we of the North are fighting, not to repel an invading foe, but to subjugate a rebellious one. Ours is the work of attack not of defense, to compel the enemy to lay down their arms, and not merely to prevent their compelling us to lay down ours. Thus far with every new danger the national heart has risen equal to the emergency. It is to be hoped that in this new trial the Government will fully comprehend the national wants, and our Generals manifest some of the enthusi asm of the people.

It is a war power. I say it is a war power, and when your country is actually in war, whether it be a war of invasion or a war of insurrection, Congress has power to carry on the war, and must carry it on according to the laws of war; and by the laws of war, an invaded country has all its laws and municipal institutions swept by the board, and martial law takes the place of them. This power in Congress has, perhaps, never been called into exrcise under the present Constitution of the nited States. But when the laws of war are force, what, I ask, is one of those laws? s this: that when a country is invaded, and two hostile armies are set in martial array, the commanders of both armies have power emancipate all the slaves in the invaded territory. Nor is this a mere theoretic statement. The history of South America shows that the doctrine has been carried into practical execution within the last thirty years. Slavery was abolished in Columbia, first, by the Spanish General Morillo, and, secondly, by the American General Bolivar. It was abolished by virue of a military command given at the head of he army, and its abolition continues to be law and all employes of the public buildings in to this day. JACKSON IN COMMAND

Final Repulse of the Rebels with Heavy Loss

The rebels attacked us, Tuesday, with a large ody of infantry, but were repulsed in gallant style by our troops. The rebels had batteries ncealed in the woods, and when our force lrove the rebels back to where they were placed they opened with grape, which made terrible destruction to our ranks for a short time, but our guns getting into position, the rebels were compelled to leave, suffering heavy losses. It but the list of killed will be given as soon a possible. The enemy's force was very strong and commanded by Jackson in person, and had not the attack been promptly met, our communication with Washington would have been cut off and trains captured or destroyed. During last night, all our trains succeeded in making their way to the vicinity of Alexandria, and acres of land there are now covered with them. The troops along the whole line were under arms all night, but nothing had occurred up to 5 o'clock, Wednesday morning, to indicate the presence of the enomy.

No anxiety need be felt for the safety of our

forces in Virginia, as heavy reinforcements are continually moving to the seat of war, and an army will soon be in the field which will drive the rebels back to Richmond.
