

Towns are assured that credit will be given them for all volunteers, and the number of men drafted will be diminished in proportion. It is next to impossible now to decide how many men the towns have furnished, for the rolls of several regiments are not complete and it is doubtful whether they will be in time for the Adjutant-General to determine with any certainty by next Wednesday the number of men to be drafted in each town. This is only one of the many difficulties by which the sub ject is surrounded. But it is no time for quibbling. We mus

take things as we find them. All that is left for each town to do is to press forward the work of recruiting and raise all the troops it can We are glad to see that our Selectmen have done the best thing they could in issuing a card assuring volunteers that in their opinion the town meeting next Monday will vote them a bounty of one hundred dollars. There is no doubt about it. The bounty will be voted. Our quota is not yet full, and no one need lay that flattering unction to his soul.

The companies now forming in this city should be filled up this week. In this way New Haven at least may be safe from all the difficulties attending a draft. It is for the other towns of our State by a similar exhibition of patriotism and energy, to relieve themselve from the same annoyance.

LETTER FROM THE CONNECTICUT FIFTH.

THE BATTLE AT SLAUGHTER MOUNTAIN-DE-SCRIPTION OF THE LOCALITY-CHARGE OF THE FIRST BRIGADE-BATTLE FIELD AT NIGHT-RETREAT OF THE ENEMY. COURT HOUSE, Aug. 18, 1862.

EDITORS PALLADIUM: The majesty of ou lovernment, the wisdom of our rulers, and the skill of our Generals have just now been demon strated in another bloody disaster. Friday afternoon we received orders to march prepared for battle, as the enemy were thought to be adancing. In a half hour we were on our way, and fast marching under a hot sun carried us six miles by sundown. Here we found the cavalry, which had been driven from across the Rapidan back to this place. Our little force of only one brigade and two batteries bivouaced that night within cannon shot of the enemy The next morning they showed themselves on Slaughter's Mountain. All the forenoon we watched them. At noon they fired on our cavalry, who were scouting through the woods. ting it so severely that it is feared he will lose Knapp's battery returned the fire from their lit. About 1 p. m. reinforcements arrived, consisting of Best's battery, 12-pounder, smooth bore. The second (Gorden's) brigade, of Williams's division, and Gen. Auger's second division, all of Gen. Banks's army corps. Here, then, we numbered between six and seven thousand men, to be opposed to a foe of unknown force. At half-past four the rebels opened fire from their artillery, which was responded to from ou guns. While the artillery fight was going on 14th Regiment a full set of Fiske's German silour brigade changed position from the extreme leit to the extreme right, and formed in the woods. Fronting these woods was a large wheat field, nearly a quarter of a mile across bounded by another piece of woods and flanked on the right by a field of sprouts. The first brigade formed here and received orders to be ready to charge on a section of a battery in the opposite wood, when our artillery ceased firing. In a few moments our artillery ceased firing, and with cheers the whole brigade charged simultaneously.

A terrible fire of musketry greeted them, and

many fell even before getting over the fence. Among them, Adjutant Smith, with a grape shot through his head. On they went, acros the field in full view of a foe superior in numbers pouring in a most destructive fire, yet themselves unseen. Half way across the field the ranks thinned fearfully. The musketry surpassed anything I had ever heard or imagined. Still they kept on, and into the opposite woods, filled with rebels, with whom they engaged in a hand to hand fight. But the contest was too unequal to last long. Our regiment had charged through two regiments of the enemy, but only to find more behind them. Reluctantly they were compelled to retreat, but fighting eve ry inch of the way. The rebels followed them up clear into the woods from which they charge d, and also coming in on the extreme right. At this time the second brigade, Gen. Gorden, come up to find the first brigade all gone, and to meet a similar fate, though not

The night before I had heard that our forces were advancing, and would probably retake the battle-field the next morning. I went up with an ambulance and me our wounded coming ou the road. Most of them had been picked up when I reached the field, but few of the dead were yet buried. May t never be my fortune, or that of any other person, to see such a sight. Dead men, both federal and rebels, were lying thickly strewn on the field and in the woods. In the edge of the wood some of the wounded had crawled for shelter, and died there with no friend to take their last message or close their eyes. Yet the wounded tell me that most of the rebels treated them kindly. They brought them water, and in some instances built booths to shelter them from the sun. But the enemy had as many of their own wounded as they could attend to The time allotted us was limited to 2 p. m., by the enemy, and there was much to be done. Great pits were dug and friend and foe sleep their last sleep together. The enemy appeared quite fair. I met quite a large number of them both officers and privates on their neutral ground. Among others, the rebel General Earley. He said he was willing to allow the Surgeons to go anywhere among our wounded, but confined all others to certain limits. When I first came into the field I thought our troops ad advanced and occupied it. Seeing a group of rebel soldiers carrying off the muskets which our wounded and dead had dropped, (to me a strange proceeding) I asked them if they were prisoners, to which they smiled and said no. I arterwards found we were there by permission and that the enemy held the field.

On Tuesday it was discovered that the enemy had left, and it would be safe for our forces to advance. So they have advanced. We claim a victory. I do not see why, unless it was Jackson's plan to advance to Washington, in which case we have simply stopped it, not beaten him. But were we to come to any such conclusion, we should do injustice to the facts in the case: and no doubt the nervous Parson is of this would imply.

The military establishment of the United States is now being put into such a condition that early in the fall, very probably sooner, the terrible energy and power of the government will make itself felt and realized with crushing force in every city, town, and hamlet of Secessia. The thunderbolts of war are now being forged and charged with an awful, death-dealing, treason-subduing power. By the end of September our armies-before that time greatly reinforced-will be almost irresistible in numbers and power, and one million two hundred thousand men will be hurled like an avalanche upon the "plundering and perjured hordes" of Jeff Davis' bogus confederacy.

More than this. The loyal states educated into the belief that we are engaged in a contest ous, and wily foe, will be preparing for still further demands upon their patriotism, their energies, and their zeal. And if need be that still heavier drafts of men shall be called for, they will be forthcoming, and at the stamp of authority new legions of intelligent freemen will pour down upon the plains and vallies and swarm upon the mountains and hattops of Secessia, determined to conquer though blood shall crimson every stream in all the South. But there is another element of our military establishment that is yet to be developed into its full power and energy. It is the Navy. The achievement of the Monitor over the Mer. rimac sent a thrill of joy through the land. But the circumstances of the last campaign have been such that for the last few months the public have almost forgotten that any thing is left of our navy except a few wooden transports, one little Monitor whose place is unknown, and a bright record of brilliant achieve ment at New Orleans and on the magnificent water courses of the West. We are confident that some dark morning the cloud of defeat will lift its gloomy folds and that a glorious sunrise of victory will shine with cheering rays upon the now drooping banners of the Republic.

Silently but energetically the government has been completing a vast naval power, more terrible in its destructive force than all that the nations of the world combined can bring together. I say, and can demonstrate to you that two wounds in the same man are very common, and many have two, three, and four wounds received in that one charge. This will help you form some notion of the desperate

haracter of the fight. To my mind there was one thought constant ly presenting itself, as I went on that field and w men lying there dead with whom I had shaken hands just before the charge—that these men were sacrificed to little good-that they were slaughtered. It is a short and ugly sentence to write, but a horrible thing to see as I saw it. What possible good could be expected from opposing this little force to that superior one? Why were not the troops which had been lying in the rear ordered to help us? We were beaten-we were driven back from the field a half mile or more, and kept there until Tuesday. All day Sunday and Monday the Federal army feared an attack. An army to which reinforcements had been pouring i like a flood feared an attack from a foe against

So we sat there and waited until Jackson had numbered our forces, and though in drilling, organizing, or instructing slaves, it not prudent to attack. Then, under our very eyes, from within half cannon shot of our forces he rebels silently retired across the Rapidar our troops waking up to the fact that the pre had gone. The rebels had advanced on us, anni hilated one Brigade, severely cut up one whole army corps, held possession of the battle field for three nights and two days, and when our force became too large to please them, withdre-across the Rapidan unmolested.

And so it is always. We always oppose small force to a large one of the enemy, and, i by chance we mass a force superior to him, sit down and let him retire. If we cannot conquer let us give up the attempt. If we can, why let the rebels out-maneuver us every time? To sacrifice men in this way without the greatest possible good resulting, is simply murder, and such was the last battle. In the name of humanity-in the name of my dead comrades lying in their unknown graves, I say let this thing cease. The rebels are terribly in earnest. They fight for their cause. Our men are slaughtered for personal distinction, and to decide what man shall be the next Presilent. If we cannot have unity of action and an earnest desire to subdue this rebellion in the shortest and most humane way among the people, rulers and Generals, then let us surrender. Human life is too precious, human suffering too terrible, to be trifled with in this WILLIAM C. BENNETT.

And let me say a word to my fellow volun cers, actual and prospective, in all the armies of all the States.

A soldier needs, besides his soldierly drill

he good heart. But good feet are distinctly the first thing Without them you cannot get to your duty. If comrade, or a horse, or a locomotive, takes you on its back to the field, you are useless

there. And when the field is lost you cannot

retire, run away and save your bacon. Good shoes and plenty of walking make good feet. A man who pretends to belong to an inantry company, ought always to keep himself in training, so that at any moment he can march twenty or thirty miles without feeling a oang or raising a blister. Was this the case with even a decimation of the army who rushed

my comrades of the Seventh? A captain of a company, who will let his men narch with such shoes as I have seen on the feet of some poor fellows in this war, ought to be garroted with shoe strings, or at least compelled to wash the feet of the whole army of the Apostles of Liberty.

If you find a foot-soldier iying beat out I the road-side, desperate as a sick man, five to one his heels are too high, or his soles too narrow or too thin, or his shoe is not made straight on the inside, so that the great toe can spread

into its place as he treads.
