you need nelp or advice in these cruss, you should The Military Selective Service Act (MSSA) and a current Presidential Proclamation require that all males born since January 1, 1960, who have reached their 18th birthday, be registered with the Selective Service System.

Please inform each concerned individual in your custody of this requirement. This is particularly important at the time an individual is an individual is released. The specific information is:

- Males, born since January 1960, who are 18 years old should have registered already, unless they were incarcerated at the time they were required to register.
- Unless incarcerated, a person's registration should be accomplished during the 60 day period commencing 30 days prior to their 18th birthday.
- Persons who are incarcerated at the time they are required to register must register within 30 days of their release from confinement.
- Registration may be accomplished at any classified U.S. Postal Service office within the United States, its territories or possessions.

Your cooperation and assistance will be appreciated.

You will be contacted either in person by the staff attorney or by mail. Again, LAP can help you only with civil legal concerns, not with criminal matters.

*** REFERRALS ASSISTANCE ***

The Department of Correction has made arrangements with several community based organizations to provide services to inmates who are about to be released. The services offered cover items such as assistance in locating jobs and housing, family counseling, and referral information. If you are sentenced and feel that you need help or advice in these areas, you should contact your counselor and request to be referred to the agency which has been designated for the town which you will be living in on your release. Referrals are made based on geographical area. Again, all sentenced men are eligible.

ITEM: PUBLICIZING THE HORRORS OF PRISON LIFE

The old adage, "An ounce of prevention is worth a pound of cure," is being put to a new test by a group of private citizens in Pennsylvania. The group, the Pennsylvania Cormittee for Effective Justice, is sponsoring an advertising campaign to go hand in had with the state's new mandatory sentencing law in the hope that would be criminals will have second thoughts.

The new law, which went into effect in June, provides five-year prison terms for persons convicted of crimes involving guns, for repeat violent offenders and for those who commit violent crimes on public transportation vehicles. The committee is

attempting to play on the fear of such long prison terms to reduce crime.

Thus far, the committee has raised \$45,000 for advertisements and for billboard messages that focus on the harshness of life in prison. In the advertisements, prison inmates graphically describe prison life. "Steel, concrete, cold, hatred, bitterness. This is every single day," one inmate testifies in one advertisement.

The committee concedes that its advertisements don't stand much of a chance of scaring hard-core, repeat offenders. But it does hope the prospect of mandatory prison sentences and the depiction of life in prison will strike fear into the hearts of those persons who might be considering committing a serious crime for the first time.

The mandatory imposition of lengthy prison terms has long been advocated as a way to prevent those who commit crimes from being set free quickly to victimize society again. The use of an advertising campaign coupled with tough sentencing policies is a new twist. Perhaps it will prove to be an effective tool in reducing crime rates.

ITEM: DEATH ROW RANKS SWELLING

WASHINGTON - While there have been only four executions of Death Row inmates in the United States since 1976, by 1984 there may be up to three a week, the Justice Department says.

In an annual report on the nation's death row population, the department said many of the more that 800 inmates are nearing the end of exhaustive appeals and

getting closer to execution.

Benjamin Rehnshaw, acting director of the Bureau of Justice Statistics, wrote in the report that was released Sunday: "The situation is ripe for the nation to witness executions at a rate approaching the more that three per week that prevailed during the 1930s. We will then have a grim arena in which to conduct our national debate on the efficacy of the death penalty."

Only four men have been executed since the Supreme Court reinstated capital

punishment in 1976, while the death row population has grown steadily.

NEVADA - Two months ago, Donna Stoeffler was among 450 people who walked out of a mass hypnosis session and tossed their cigarettes into a fire, vowing never to smoke again.

Stoeffler quit for about three weeks before breaking down after "kind of a rough weekend," but the organizers of the "Great Nevada Smokeout" say more than one-

third of the participants are still off cigarettes.

About 10 percent of this town's residents turned out for the session May 6. Hypnotist Greg States runs professional hypnotism clinics in Des Moines to help smokers kick the habit and said the experiment was his first try at mass hypnotism.

Follow-up checks showed that 34 percent of the people who attended the session have given up cigarettes completely - much higher than the 20 percent to 25 percent success rates of other programs, he said.

Later in May, States conducted a similar experiment in Creston with 250 people.

He claimed an even better success rate there - 43 percent.

Among those who kicked the habit completely in Nevada was Betty McKim, who said that saying goodbye to cigarettes was "sort of like giving up a special friend." Many others quit for a while, then started again but have reduced their smoking,

States said.

"Some people have cut from three packs a day to one or two cigarettes a day," he said. "We're real pleased with that,"

States said the purpose of the smokeout was to gather data about the effectiveness of a single hypnotism session, and learn why some people didn't quit for good.

"Me're going to really plunge into when they started again, how long they lasted,

what caused them to start again," he said.

"The goal of all this is it's going to be put in a manual for others to use in helping people quit smoking," he said.

ITEM: SEE NO EVIL

Disenchanted with television, the Moral Majority is launching a national campaign to "clean it up," The group is apparently convinced that the networks have become an open sewer with programming material that constitutes a frontal attack on "the traditional family and moral values of this great America."

Moral Majority members are receiving an "official" ballot asking for their money and their views on such predictably-worded questions as: "Are you in favor of America's children being subjected to the presentation of homosexuality as an acceptable lifestyle on prime-time television?" and "Are you in favor of television programs which major (sic) in gratuitous violence such as murder, rape, beatings, etc.?" There seems little doubt as to the "official" results.

One hesitates to defend network television-much of the programming does feature gratuitous violence-but Jerry Falwell's fundraising letter makes no mention that at least some of the shows negatively cited dealt with subjects like rape and sexual abuse of children in a sensitive, frank manner so as to raise consciousness in the viewing public. We can't simply ignore these problems and pretend they don't exist. And it does no good to nostalgically yearn, as Ronald Reagan does in a quote from the Moral Majority brochure, for the days "when the actors kept their clothes on."

FORT WORTH, TEXAS - No regrets, says Alexander the Great.

It's been highs and lows, peaks and valleys, heart breaking. Broken broncs, broken records and broken bones.

It's been Cheyenne and Denver and San Franciso and Oklahoma City and Houston and Albuquerque and Kansas City and Phoenix and Reno and Dallas and Fort Worth. It's been one wife, five world bareback championships, \$500,000 in prize money and hundreds of thousands of miles via car, bus, plane, taxi and hourseback.

And the best fight you ever saw, grins Joe Alexander, 38, a native of Jackson Hole,

Wyo, and now a Marysville, Calif, rancher.

But it's almost quitten time, says Alexander, one of professional rodeo's winningest bareback riders and, his colleagues say, one of the nicest guys. It was the late sports columnist Red Smith who nicknamed him "Alexander the Great, Which is a little deceiving. At 5-foot 8 and 155 pounds, Alexander more closely resembles a gentleman jockey than a rider who dominated bareback bronc competition during much of the last decade. Size, says Alexander, is inimportant. You got to have timing, a rhythm with the animal, and you got to be fairly strong and agile, with good balance and a good attitude." And being a little crazy "wouldn't hurt, "he adds. Since 1970, when he began specializing in bareback riding, Alexander has won five world titles and two Professional Rodeo Cowboy Association crowns.

He qualified 12 times for the Natoonal Finals Rodeo, which is to the nomadic cowboy what the World Series is to baseball and the Super Bowl to football. But Alexander

last world championship came in 1975 and his final PCRA title in 1977.

I kept saying I was going to take some time off and slow down I never did. As a collegain, he became enamored of roding, comprting in saddle, bronic bareback and bull riding, as well as steer wrestling and ribbon roping.

I never liked the bulls, Alexander recalls, I did it to help the team get points. I could ride them pretty well, but they scared me." They scared him mostly, he says, when they stepped on him, which was not infrequently. I was always about half crippled." Bareback was something else, It was easy for me. A piece of cake."

He won the National Intercrollegiate Rodeo Association Bareback championship in

1966 and was runner- up in 19 67.

About the time Alexander was seriously considering a rodeo career, the sport was undergoing sweeping changes. Casey Tibbs and Jim Shoulders and Harry Tompkins and Bill Linderman were household words, but mostly in old households. Rodeo needed new blood and a new image.

It was supplied by one Larry Mahan, who would do for rodeoing what Arnold Palmer did for golf. He was the best thing to ever happen to rodeoing, says Alexander, who like Mahan, is a non-smoking athlete with no time and little inclination for boozing and brawling.

Like Mahan, Alexander chose not to walk on the wild side, saying, I could name you a dozen really good guys who traveled in the fast lane. But they didn't last long." Alexander recalls the heady moments when he won his first national title in 1971, and his last, with an amazing finish, in 1975.

"It makes you feel super, he says. "Like it's all worthwhile. The money's not to bad, but more importantly, you feel like you're on top of the world."

And then there were the other times, like Ellensburg, Wash, and a. horse named

Necklace. Necklace nearly killed him.

Got my hand hung in the bareback rigging, Alexander remembers vivdly. Dragged me around the arena a lap and a half. And it was a big arena. She kicked me in the head and knocked me unconscious. She finally stepped on me -both legs- and pulled me loose."

"Last year, I got my hand caught in the rigging at Stonyford (Calif.) "says Alexander. The horse pulled me under him ... and fell on me. When he whirled to take off,

I was lying face up. He stepped on my cheekbone with his back foot.

Crushed my cheekbone in. ""

That episode required major surgery and two months of recuperation. In 1980, Alexander thought of retiring not coincidentally after suffering a neck injury in the World Finals He did reduce his rodeo pace from a high of 140 to 60 last year.

He still won \$40,540, qualifying him for a 12 th, consecutive trip to the finals

at Oklahoma City. He finished last, for \$.1,000.

Age, he says, is taking it's toll, and not just physically.

"There was a time when I wanted to ride everything that came down the road. But after 10 years, I've kind of got to looking around and thinking that maybe I was missing, some things."

"Alexander does not appear to have lost his movitation, which he defines as a "burni-

ing desire to succed, coupled with a nagging, fear of failure."

OLIVIA NEWTON-JOHN HITS THE ROAD

HOLLYWOOD, Olivia Newton-John will hit the road, perhaps for the last time, this summer with 50 One-night concerts in a span of two months. Beginning in Washington, D.C, Aug. 9, Olivia will cover the East Coast, New England, the Midwest, South, Southwest and West Coast. Streisand, Midler and Ronstadt notwithstanding, Olivia is the hottest pop singer in the country today, still reaping a fortune from her "Lets Get Physical" album which was No. 1 in Billboard for 10 weeks. All of her dozen albums have gone gold, from the very first—"Let Me Be There" in 1973—through "Physical."

PHYSICAL, Like six of her previous albums, reached platinum status (more than 2 million copies sold), and became a highly rated one-woman television special earlier this year viewed by 31 million Americans. Is it any wonder that Olivia's cross-country

concert saga will be called "Physical Tour of North America"82?

Olivia strolled into MCA Records headquarters the other day looking like a woodland nymph. She wore a green and white handprinted tunic over red tights and red boots, rolled down at the top, that came almost to her knee. It's been four years since the delicate blonde Australian beauty youred. In the interim she did television, record and started in two movies, "Grease," the most successful box-office musical in history and "Xanadu,"

Olivia, 33 is a millionaire many times over. Indeed, she need never have worked after the Grease, album, which sold an incredible 10 million copies. Now lets see, at

\$1 each as Olivia's shear that's ... hrmmm.

Now she must leave her horse ranch at Malibu and her live-in boyfriend of three years, several years her junior, for the arduous tour. Why, Olivia was asked, has she elected to hit the road?

She gave the question some thought before answering. "Because it may be my last opportunities." I'm doing this for my fans. Most of the letters I get ask me when I will appear again in their part of the country. They want to see me.

I've done about everything I could dream of in recording, films and television. I'm afraid of becoming complacent. So my personal goal at the moment is to see if I can do it all over again.

"When you become popular, you also have a growing desire not to disappoint the people

who buy your fecords or see your movies."

Olivia is astonishingly unchanged from the wide-eyed Hollwood newcomer of a decade ago. She separates her fans into three categories, those "who go all the way back to the old days, those who tuned into Olivia with "Grease" and the pre-teens who never heard of her before "Physical"

"I saw a singing star 10 years ago and was disappointed when she sang only a few of her wellknown songs in a medley, "Olivia" said "I told myself I'd never do that. My concerts will be composed of the songs that made me famous. The first five years of my career. The second half will be the songs since 'Grease.' I'll include a couple of new ones, too. if this is to be Olivia's final tour, what plans does she have for the future?

"Movies," she said. "After 'Kanadu, I didn't want to make any more mistakes. I agreed to do that film when it was only an idea without a script.

"ROOTS" AUTHOR TELLS HIS KIN OF A NEW BOOK"

Haley, whose work brought the saga of this black American family to life, was swarmed by more than 300 relatives from Los Angeles, his current home, Washington, D.C, Chicago, Detroit, and Kansas City - all wanting an autograph, a snapshot, a hug, a kiss or a word of greeting from the family celebrity.

A tour of Henning took Haley's relatives to his grandfather's old saw mill, by the gravesites of their ancestors, and to the gray, two-story frame house where Haley's grandmother would sit on the porch and tell and retell the young Alex about

his roots.

Before settling down to a picnic at the Alex Haley Park on Highway 51 about 50 miles north of Memphis, the author told the group his new book, to be entitled "Henning," will study the lives of the townspeople he knew.


