

7 RE: State v. Licari, Validity of Arrest Warrant: Jurisdiction; Illegal Arrest; Bench Warrant Defective & Waiver Thereof; Defendant brought to trial against his will: Jurisdiction of the person may, on the other hand, be acquired by concent of the accused or by waiver of objection, and it is waived by pleading not guilty and going to trial. See: Albrecht v. United States, 273 U.S. 1, 8, 47 S. Ct. 250, 71 L. Ed. 505; 21 AM. JUR. 2d. Criminal Law, Sec. 379.

8 RE: No Knock Law: Officer must state his authority and his purpose at the threshold. Entering defendant's room by use of passkey obtained from hotel clerk illegal. 18 U. S.C.A. Sec. 3109, Munoz v. United States, 325 F2d 23 (9th Cir. 1963). REVERSED

9 RE: Defining arrest as to certain particulars and actions including words. Alexanders Law of Arrest, Volume 1.

10 RE: In this case an officer was defined as 'the detention of a known or suspected offender for the purpose of prosecuting him for a crime, and as noted in this case a detention has occurred only when there is a touching by the arrester or absent that, when the arrestee is told otherwise understands that he is under arrest and he submits... II RE: <u>Conspiracy</u>: The mere presence of a third person in automobile with parties to conspiracy to sell counterfeit gasoline ration coupons at place where the conspiracy was to be consumated, afforded no reasonable ground for arresting him without warrant. #### 14 RE: PROCEDURE

C.A. Colorado 1969 - Aperson must be advised that he is being arrested and the reason therefore unless such person either knows or has reason to know that he is being arrested and why. NOTE: This action was brought by civil rights act for suit alleging illegal arrest. The court of appeals affirmed in the matter dismissing the suit, plaintiff did not seek certiorari. Schindelar v. Michaud, 411 F2d 80.

#### 15 RE: ARREST KEY 68:

C.A. D.C. 1969 - Arrest, under Fourth Amendment, cannot be effected in a vacuum, and there must be knowledge of situation on behalf of both suspect and police. (Per Tamm, Circuit Judge, with one judge concurring in the result) U.S.C.A. Const. Amend. 4. Yam Sung Kwai v. Immigration and Naturalization Service, 411 F2d 683 (1969). NOTE This case concerns a search and seizure, defines Terry v. Ohio, and should be used on the brief.

#### 16 RE: ARREST KEY 63 (1):

C.A. Va. 1969 - Summart arrests and searches on general suspicion, without warrants or probable cause, are intolerable, even if in a particular instance such police behavior proves fruitful. Jones v. Peyton, 411 F3d 857.

#### 17 RE: ARREST KEY 63 (3):

C.A. Minn. 1969 - Primary concern on question of probable cause for arrest of defendant as robbery suspect was not officer's state of mind at time of arrest but whether, viewed in retrospect, objective facts were such as to justify prudent person believing that he had enough facts on which to base arrest before search was made which led to finding of bullets, pistol, and money on defendant's person. 18 U.S.C.A. Sec. 2113. United States v. Skinner, 412 F2d 98 (1969).

#### 18 RE: ARREST KEY 71.1(8):

C.A. Fla. 1969 - For a warrantless search of an automobile under police control to be lawful it must be closely related to the reason for the arrest and the reason the automobile is in custody. U.S.C.A. Const. Amend. 4. Williams v. United States, 42 F2d 729.

#### 19 RE: ARREST KEY 71.1(8):

C.A. Tex. 1969 - Where defendant was arrested and searched, though not thoroughly, he was taken to jail and given prison garb, and his clothing and effects were put in a bag in prisoner's property room for routine safekeeping, and three days later defendant's clothing was searched without search warrant, and herion was found in watch pocket, search was invalid and fruits were not admissible for any purpose. U,S.C.A. Const. Amend. 4. Brett v. United States, 412 F2d 401 (1969).

#### 20 RE: ARREST KEY 71.1(11):

C.A. Fla. 1969 - While mere suspicion clearly does not measure up to probable cause, Henry V. United States, 361 U.S. 98, 80 S.Ct. 168, 4 L.Ed.2d 134 (1959), and an arrest may not be justified by what is seized thereafter, Johnson v. United States, 333 U.S. 10, 68 S.Ct. 367, 92 L.Ed. 436 (1948), nor may an arrest be used as a mere pretext to search for evidence of a crime. United States v. Sanchez, 412 F2d 1177 (1969).

## The Rap Of The Gavel

In an endeavor to acquaint all of you that are concerned with the intricacies of the law and the administration of justice, I am going to try and explain the ways that you as a defendant can alleviate much of the burden that is placed upon you in the Courts by the recalcitrant system. Most of the material contained in the "Rap of the Gavel" is received from the New York Law Journal and the American Bar Association's Committee on the Administration of Justice to Indigent Defendant's. Comments are my own and are not attributed to anyone other than myself unless otherwise specified.

I believe the first point that is to be brought to light because of its benefit to our own personal existance is the most recent prisoner's self-help decision rendered by the United States Circuit Court of Appeals for the Seventh Circuit. The matter arose in the United States Correctional institution, Marion, Illinois, when the defendant in the matter, a prisoner at the institution observed a felolw inmate being beaten by numerous prison guards. The defendant rushed to the inmates aid and proceeded to assist the inmate in extricating himself from the administration of the quards. The matter was subsequently brought to trial in the United States District Court at St. Louis, and the defendant was convicted. He appealed and the Court of Appeals reversed stating "A prisoner is privileged to use reasonable force in the defense of another prisoner if the defender believes that the other prisoner is being subjected to an unprovoked physical attack by prison guards." Excerpted from U.S. v. Grimes, 413 F2d. 1376 (7th Cir.).

It would seem that we the inmate have been somewhat recognized as a person with qualities similar to those displayed by human beings. As such we retain the right to protect ourselves and our fellow inmates in the event that we are being brutally beaten for no apparent reason. This

would seem to lend evidence to the fact that administrators are being severly reprimanded for being so recalcitrant in the function of carrying out the orders of the Court.

The protection we so desperately need is to be found only in the Courts that have sent us to these dens of iniquity. They are slowly realizing that we retain certain rights and these rights must be preserved.

I am sure that within the next few years drastic changes will be made in the penal colonies throughout the nation. We ourselves must strive to better the world that has been forced upon us yet in the doing be careful not to place ourselves in any compromising situations that would enable us to be subjected to attacks whether they rightful or not.

Our main concern is to do the time that we have received in the easiest possible manner. Please do not interpret this to mean that we should lose our identity as individuals or that we are to eat humble-pie. If we are forced to do so we become enemies of ourselves and therefore our existance in life becomes meaningless.

"CONFINED DRUG ADDICTS HELP THEMSELVES"

My name is John W. Maura and I am a member of "EMPATHY." Empathy is the name of a Jaycee drug project for ex-drug addicts at the Somers Correctional Institution. Webster define's Empathy as the capacity for participating in anothers feelings or ideas. Our program is a self help project totally staffed by ex-drug abusers who provide the identification and therapy needed to meet the many drug rehabilation challanges. It is our belief that former users are best qualified to help the person who wants to stop using drugs, since the users know the users best, they have the Empathy.


Our program consists of sensitivity sessions, seminars, probes and encounters. We learn with these tools, to understand ourselves and our brothers around us.



We learn with these tools, to understand ourselves and our brothers around us. We have an interview board consisting of five men. These men determind a prospective members sincerity and whether or not he will be accepted as a new member. Upon acceptance he is made aware of group policies. They are, no physical violence, no use of narcotics or drugs of any kind, mandatory attendance and maintain strict group confidence. Violation of our policies results in learning experiences felt appropiate by the group. If the member does not comply with the learning experience meted out by the group it is an indication that the individual doesn't want to help himself, therefore we can't help him. We also have a crime prevention committee that works with us when we make our tapes for the schools around the state on narcotics. Crime prevention is also part of the Jaycees which also make tapes on crime. Here the men write out letters to schools around the state, asking if they have any questions on drugs, narcotics, etc. In return we answer these questions on tape and send them back to the schools. This is helping a lot of our youth we hope.

The men in Empathy realize that they were rejected by society, and are now determined, through the use of treatment, to be accepted back into society. We want the people of our communities to know we are doing something to help ourselves. We understand that there is an unbelievably increasing rate of drug abuse and addiction which has crossed all economic, social, religious, educational, and geographical boundaries. It has encompassed a large part of our present day youth. It is evident that a full concerted effort to deter this social disease is of paramount importance. "EMPATHY" began with this in mind in order to lead the "Bandwagon" in the Institution just as other programs such as Synanon, Daytop Village, Pheonix House, etc. Have done in the community.


