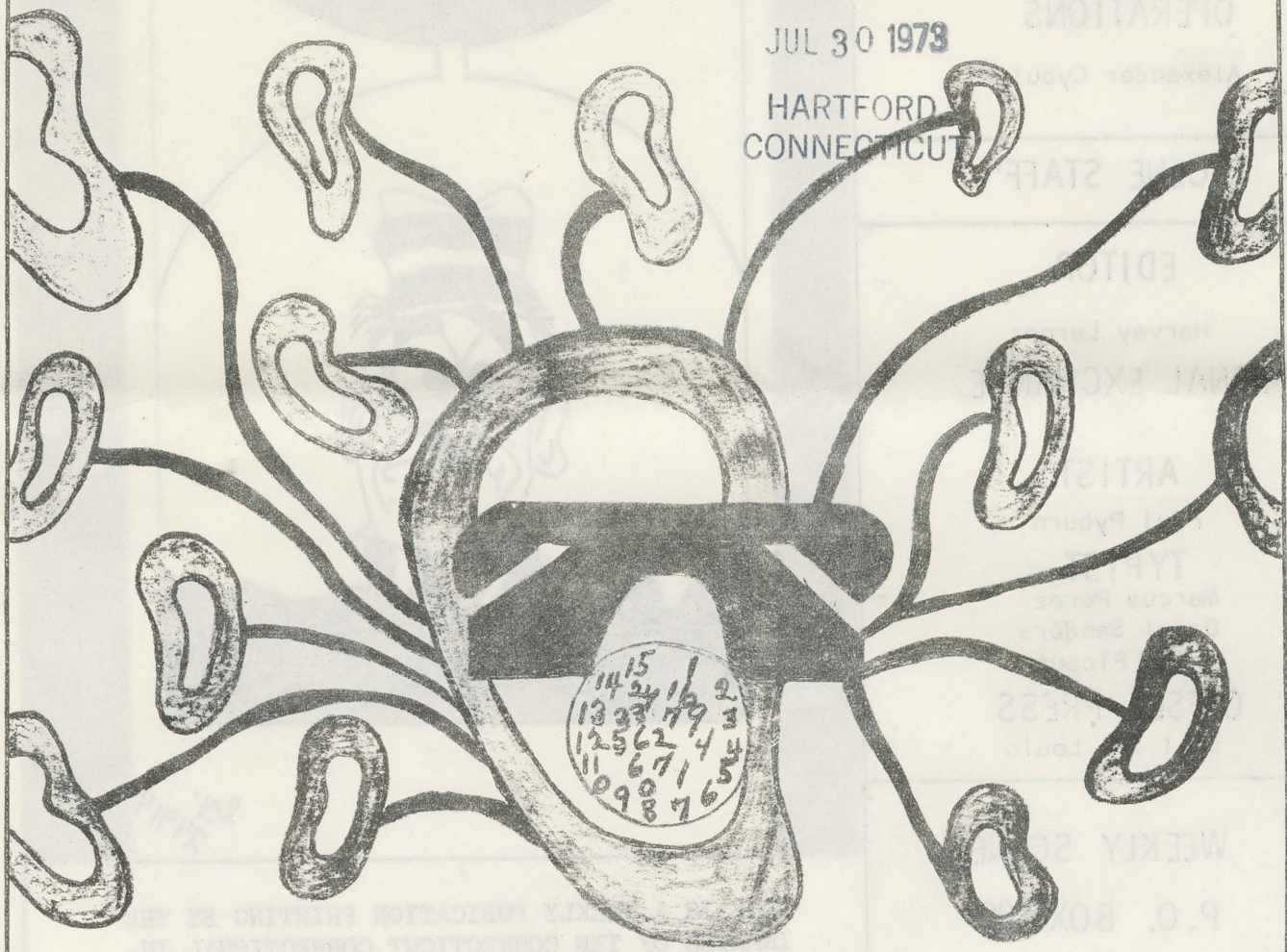

PARDONS BOARD

FALL SESSION MEETS ON THE FIRST AND THIRD MONDAY IN OCT. AND THE FIRST MONDAY IN NOV.

APPLICATIONS: All inmates who are planning for appearance at the next sessions are encouraged to submit their requests to Mr. Seama, Records Supervisor.

These requests should be submitted immediately, if possible, and inmates are reminded that the last day for receiving requests is: August 17, 1973.

APPLICATIONS RESULTING IN A STARRED (*) CASE:

Under the established rules of the Pardons Board, cases cannot be heard if the petitioner has:

- (1) Appeared within a year.
- (2) Served less than a year. This year cannot include jailtime.
- (3) Appeared or was eligible for parole.

It is also the policy of the Board not to hear a case if the petitioner has any pending legal action, such as an appeal or writ of Habeas Corpus.

A starred case in one of these categories is very rarely heard. By, therefore, waiting for a regular session, not only are inmates saved the labor of preparing required letters, but friends, lawyers, prison staff, State Attorneys, and the Board, are spared the efforts which should be given the regular petitioners.

It is suggested that before undertaking the task of a starred petition, an inmate should seek the advice of the prison staff which is readily given.

All inmates should be advised that no attorneys will appear for them, including Attorneys from the Public Defender's office, unless they specifically make arrangements with the attorneys in advance.

For the Fall session, the Board of Pardons will hear the cases for Fairfield, Litchfield, Middlesex and Tolland counties on the first Monday in October. The counties of New Haven and Waterbury will hear cases on the third Monday in October, and the cases for Hartford, New London and Windham counties will be heard on the first Monday in November.

sick blues."

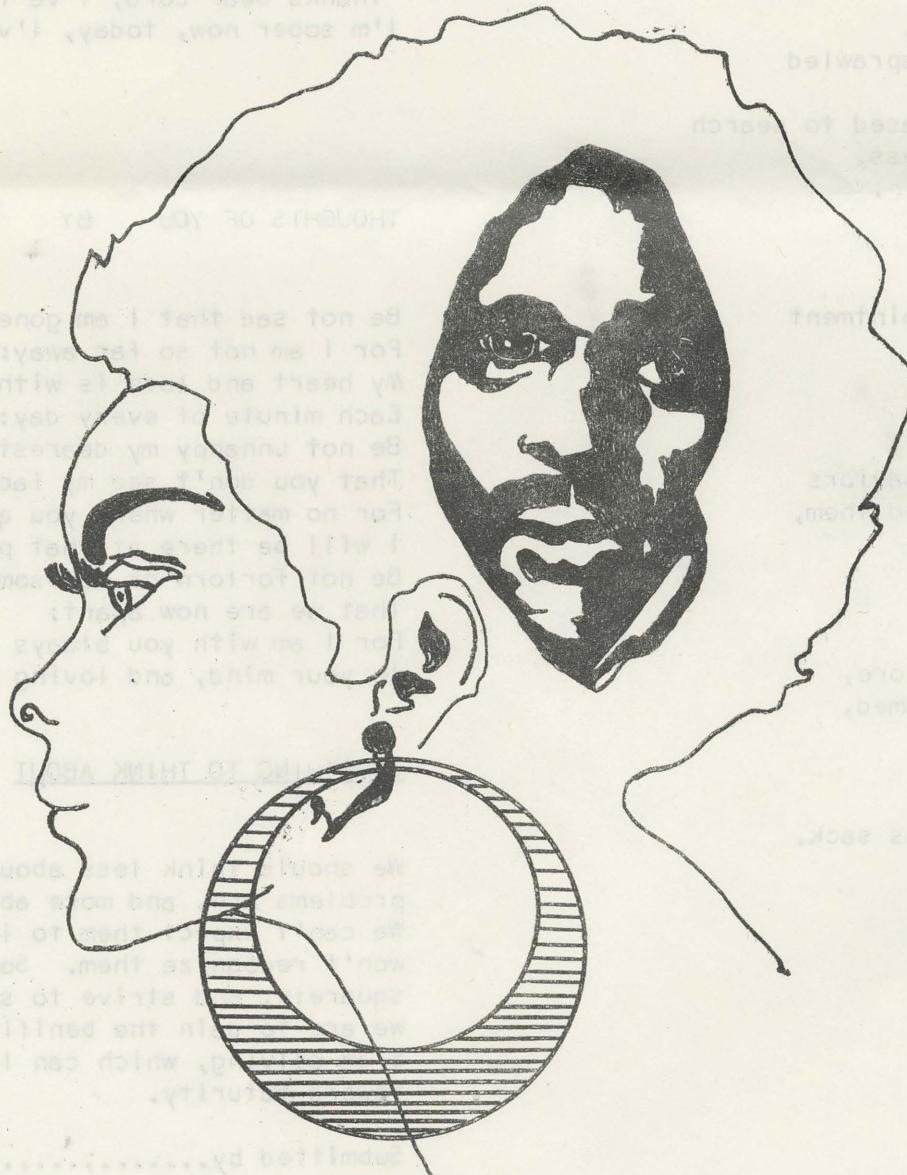

And then I would suggest that you check out your history and more importantly, that you check out "your mind". The answer is there...

Ask yourself too, why are you in this dungeon of hell and not out there on the streets, providing for and protecting your children, woman and your family. They need you, who is going to provide for them now?

Education my Brothers, skills for building a nation, knowledge to make you a more beautiful Black man - a more human person, concerned about the fate of humanity on this very confused planet.

For those of you who read a newspaper occasionally or accidentally watch the news, you will know that, on the twenty sixth of May, African people all over the world, came together in an expression of unity and solidarity, to celebrate African Liberation Day. LOTTERIA

Coward Hosell: As I See it.

Once again it is sports night in that now famous citadel of fisticuffs aka Somers Correctional Institute, located in the sleepy northern corner of Connecticut. Here we watched on the evening of July 2, 1973 as the mighty legions did battle before a SRO crowd of ardent fight fans. Now, as always, my eye witness account of the action that memorable night.

Fight # 1 pitted Guzman vs. Smith. Round 1 action was quick and strenuous as Guzman and Smith both landed blows of no small accord. From ringside it appeared that Guzman landed a blow or two more but Smith was undazed as the round ended. At the start of round 2 a small trickle of blood appeared on Guzman's nose, that the result of a sharp jab from the hands of his worthy opponent. Later action had Smith landing more often and with more authority. As the fight wore on to its inevitable climax in the third and final round the bleeding seemed to bother Guzman more and more. Smith landed a couple of cutting jabs near the end and was in fairly good shape at the bell. Smith was the winner on rounds 2-0.

Fight # 2 matched Walker against Derien in a hard hitting test of endurance. Round 1 began slow enough but it was no forecast of the explosives yet to come. Derien caught his taller foe in a neutral corner and sent him to the canvass with a crisp right. Walker rose quickly at the count of two. This knockdown was similar to the knockdown Walker received in his first fight some six weeks ago. Round 2 started as quickly and explosively as any round this writer has seen in some time. Walker landed with a right to the jaw and a left to the head that sent Derien to the canvass for an 8 count. A game Derien rose to his feet and the action moved to the corner where another right sent him down for the second time and for the second time he got up to continue. Walker unrelentless in his pursuit, scored with a combination that sent Derien down for the third time, hitting his head on the ropes on his way down. The referee had apparently seen enough, as he stopped the fight at this juncture, awarding a TKO to Walker. One must comment on the good sportsmanship of Mr. Derien, who offered no excuses at the end but rather gave his opponent his due praise.

Fight #3 - Crosley vs. Pinnell. All things considered this was a rather slow fight from beginning to end. Rounds 1 and 2 saw a trading of jabs and good infighting but no hard

Fight #8 - Forbes vs Lewis. The first round was controlled by Lewis as far as setting the pace was concerned. However Forbes landed the majority of the punches thrown and the ref scored it 5-4 in favor of Al. Round 2 began with the pace picking up somewhat. Both foes landed well in the clinches and moved well at the perimeter. The ref had this round 5-4 in favor of Lewis making the fight a dead draw as they headed for the home stretch. Forbes was tired slightly as round 3 began. He used his favorite weapon, the old rope trick, to his advantage twice, but the third time he tried this method of attack Lewis was waiting and nailed him with a sharp right to the body. The ref scored this round 5-4 in favor of Lewis giving him the decision on the narrowest of margins 14-13.

Fight #9 - D. Huckaby vs. Alesia (Springfield). The final fight on the card and perhaps the best one of the night. Certainly the crowd was pleased by the final outcome. Huckaby, much taller than his opponent, set the pace in the early going landing rights and lefts to his opponent's jaw. Alesia, you may remember, is the man who defeated Forbes last time around in a controversial fight. There were those who wondered how a "pro" got on the card in the first place. Well, the erstwhile Mr. Huckaby is no newcomer to the ring himself, and he aptly demonstrated his talent this night. In round 2 Huck bombed Alesia with everything but the proverbial "kitchen sink" landing blow after blow at will. And mind you, these were no soft taps, these were blows that would have floored a lesser man than Alesia. Still, Alesia kept on coming back for more and more he got. Huck continued his relentless attack in the final round, dazing Alesia but never landing that one knockout punch. Near the end of the fight it seemed that Alesia was on his way down but somehow he managed to continue to the final bell on his feet. Huckaby received a well earned victory, the kind that sends one on the long road towards a championship.

punches were to be seen. Round 3 began with a hard tirade from the hands of Crossley. Pinnell cut Crosley's nose with a left jab near the end of the fight. The referee gave the fight to Pinnell by a 2-1 margin causing a loud barrage of catcalls from the highly partisan crowd. One observer wondered just where the ref was looking and this writer must concur with that opinion.

Fight #4 - Mauldin vs. Garcia. The return to the ring of Highly popular Snake Mauldin was a letdown to his ardent supporters. The fight probably could have gone either way but alas there is but one judge and referee. Round 1 had Garcia landing the only blow of any account, that being a right to the jaw. This round saw a lot of sparring in center ring. In round 2 fans were treated to more of the same, with both fighters landing good jabs, but missing on their hooks. The pace picked up some in the final round with Garcia landing 2 rights to the body and then missing a third as Mauldin put a "purty" move on him, sidestepping the blow. All in vain though as he missed an upper cut that could have turned the tables in his favor. Garcia won on a unanimous decision.

Fight #5 - Green vs. Rodriguez. This was another slow moving bout smartly fought by both men. The first two rounds were controlled by Green by a wide margin. He landed consistently with punches to the head and body. Green appeared to tire slightly at the end of the 2nd round but when the third round came up he got his second wind, scoring with lefts and rights. Green was declared the winner on a unanimous decision.

Fight #6- Roberson vs Jordan. The beginning of the round gave no indication of the explosives to come. Roberson landed with a crisp right cross at the outset, but suddenly was in trouble as a hard right to the jaw sent him to the canvas. He was up at the nine count and asked to continue but the referee, wary of permanent injury, stopped the fight giving a TKO to Jordan.

Fight #7 - Clinkscales vs Jenkins (Hartford). Again a surprise ending to this one. Round 1 had both men exchanging blows on the fringes of the ring and scoring equally well. The ref scored this round 5-2 in favor of Jenkins. Round two saw more of the same action viewed the 1st round and it appeared that this one might go the full 3 rounds when Clinkscales suddenly threw in the towel, apparently too tired to continue.

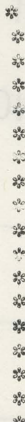
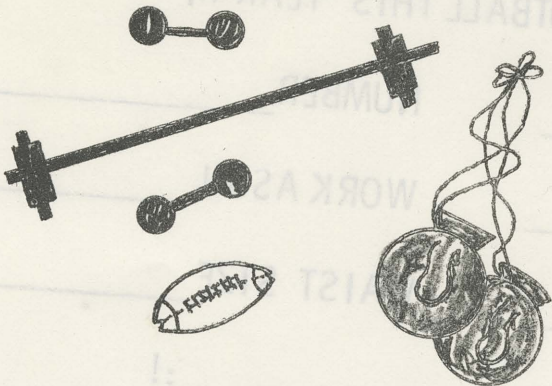

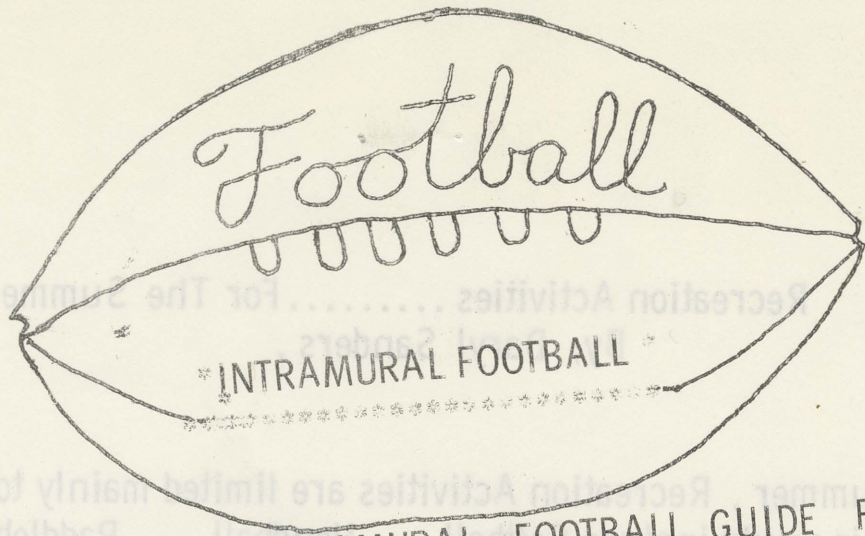
